MILEAGE CRITERIA FOR TEAM FLORIDA AAU JUDGES

- . Judges are expected to carpool whenever possible
- . Driver of the carpool will receive .40 per mile, full mileage to and from meet site, as well as to and from hotel if applicable.
- . Judges who ARE NOT ABLE to carpool will receive .40 per mile, full mileage. It is expected that if possible, solo judges are to carpool to and from meet site from hotel, if applicable.
- . For judges who ELECT to pull out of carpool, judge will be paid .40 per mile LESS the first 35 miles. No mileage reimbursement will be given for drive to and from hotel, if applicable.
- . All judges must present a hard copy of Mapquest mileage to and from meet site. This document must accompany the voucher that is submitted.
- . Only the Team Florida AAU voucher will be used for Team Florida meets, not the NAWGJ voucher.
- . The director of the meet will notify judges of round trip mileage to/from hotel, if applicable, or if the meet director prefers, the round trip mileage will be determined by one judge who is staying at hotel and provide this information to all drivers eligible for hotel mileage reimbursement. If the meet ref is staying at hotel, he/she will determine mileage to/from meet site and provide this information to all drivers eligible for hotel reimbursement. If meet ref is not staying at hotel, meet ref will appoint a judge to record hotel mileage and present to meet ref. Everyone is required to use the mileage info given to them.
