

KrisCross Gym Policies and Procedures

Gym Rules

1. Parents must walk their Child into the gym!
2. No Gum inside the Gym!
3. Parents/siblings are not allowed in the gym during classes except for Mommy and Me.
4. No shoes on the gym floor! (cheer shoes are allowed)
5. Water only in the gym area

FUNDRAISERS

KrisCross Gym will hold two fundraisers during the school year! The 1st fundraiser is to help you with your child's tuition, uniforms, etc. We will credit your account if you participate. This credit will be applied to your account in September. The second fundraiser is to help buy new gym equipment. We ask that all members help with the fundraisers to make them a success!

WITHDRAW POLICY

The ONLY Acceptable types of notice is a 30 day notice include e-mail or written, dated notification to quit. If you choose to just quit attending classes, your child will still be charged until notice is given and no refund will be given.

GYM FEE/INSURANCE FEE

In order to pay your child's gym insurance, make improvements to the KrisCross facility, hold special events, add new equipment to the gym, an annual Gym Fee has been implemented. The fee is \$55.00 a individual, \$75 for a two children or more. This fee is non-refundable. If you leave the gym and return within the same year, you will need to pay the gym fee again.

PHOTO VIDEO RELEASE

At times photographs and videos will be taken during classes, events, and other activities.
