I agree and understand that participation in cheerleading, tumbling, or any other activity that involves motion, rotation, and/or height, carries with it the risk of injury. I agree and understand that all medical expenses incurred will be the responsibility of the parent or guardian. In lieu of a medical certification signed by a medical doctor, I state that I have no knowledge of any physical injuries or impairment that would be affected by the named child's/children's participation in any program at Alpha Extreme Cheer LLC.

Alpha Extreme Cheer LLC cannot assume responsibility for children left unattended in any facility operated by Alpha Extreme Cheer LLC. Parent/Guardian(s) are responsible for the conduct of their children at all times in cheer/tumble gym premises. All children, attended or unattended, are expected to respect cheer/tumble gym property and other cheer/tumble gym patrons. Under no circumstances does Alpha Extreme Cheer LLC assume any liability for injuries, accidents or any mishaps, whatsoever, which may occur when a child is left unattended, including, but not limited to intentional torts committed by or against the child. In the event that any liability results out of intentional torts committed by an unattended child, liability shall be borne by the parent/guardian(s) of such child.

Payment Authorization and Drop Policy

You **MUST** keep a credit card on file at all times. All class fees are billed on the 1st day of each month and become due immediately. Customers must pay before the 1st day of each month to pay their account via cash or check. All amounts remaining due on the 1st day of the month will be charged to the credit card on file for the account. Any accounts with a balance due after the 4th, will automatically be charged a \$15 late fee, and the student(s) associated with the account may be withheld from participating until the account is current. This includes accounts in which the credit card transaction on their account is declined for any reason. It is the customers responsibility to update all credit card information prior to the 1st of the month to ensure payment is not declined.
