Policies and Guidelines for Parents and Students

(For this document and all future documents it is understood that SA or *Step Ahead* will be used as a substitution for Step Ahead of South Florida, Inc.)

1. Every student/participant must have filled out and have parental signature, if under the age of 18, of the Registration and Release Forms prior to his/her first day of class at Step Ahead.
2. As a parent/guardian, I agree to provide health insurance for the participant and/or guarantee payment of any and all medical expenses incurred as a result of training, performing, or participation in activities of Step Ahead.
3. All tuition is due on or before the dates specified. There will be a \$25 charge for all checks returned. Any account past due is subject to a 10% late fee. I understand that the participant may be asked to refrain from all activities at Step Ahead as a result of nonpayment. This may include, but not be limited to, removal from the all-star program.
4. Safety regulations require no jewelry allowed during class. The instructors will ask for jewelry to be removed and will not be responsible for loss.
5. **No gum, food, or drinks** are allowed in the practice area.
6. Parents will refrain from speaking to their child during class, as this is a distraction and could result in injury.
7. Parents are responsible for their child's behavior and their safety while on the premises, before and after the lesson. We encourage you to arrive 10 minutes before the beginning of each lesson to ensure your child's safety.
8. Parents are asked to come inside in order to pick up their child. We do not allow children to be waiting in the parking lot area
9. Any sibling or guest must remain in the designated viewing area. **Siblings and guests are not allowed to disrupt the practice area.** All siblings and guests will be considered the responsibility of the parent of the participant. **DISRUPTIONS AND DISRESPECT WILL NOT BE TOLERATED.**
10. Refusal to abide to any and all rules set forth by the staff at Step Ahead may result in dismissal from the program.
