Once accepted Qualifiers must attend mandatory host meeting, utilize DSCA certified judges, and must have all safety personal and required USA Cheer/USASF safety guidelines in place for event.

## **DSCA Qualifier Host Requirements**

Any organization wishing to Host or Co-Host a DSCA Qualifier must have a sponsoring member pay their dues for the current competition season, and have a sponsoring member who has been a DSCA member for 12 months commencing June 1, 2021 through May 31, 2022.

Any organization wishing to Host or Co-Host a DSCA Qualifier must also have a sponsoring member who is in good standing (has attended 1/2 (50%) of all DSCA General Membership meetings). General Membership meetings (not necessarily with the same organization) commencing June 1, 2021 through May 31, 2022.

Both the Host and Co-Host of a DSCA Qualifier must each have a sponsoring member who has met the above requirements.

An organization may either Host or Co-Host only one DSCA Qualifier between October 1, 2022 and February 28, 2023.

Any organization wishing to Host/Co-Host a DSCA Qualifier must electronically submit a DSCA Qualifier Request Form to the DSCA Board of Directors by June 6, 2022. The DSCA Board of Directors will vote on the date request and will inform the applicant within 30 days of the deadline. Upon approval an application fee of \$200.00 is due by designated date no sooner than 30 days after notification. Once fee is paid the DSCA Board of Directors will only approve a date change to a qualifier due to weather.

The DSCA Board of Directors will take into account seniority when awarding Qualifier dates. Seniority is based on the previous number of years that the Host/Co-Host has held the event. After that the following criteria will be considered:

- Compliance to USA Cheer/USASF Safety Guidelines for competition facility, surfaces, and equipment.
- Feedback from membership on experience of previous events

All DSCA qualifiers MUST attend the Qualifier Host Meeting, follow the 2022-2023 DSCA Qualifier Rules and Guidelines, have a DSCA certified judging panel, and require safety personnel to be on staff at your event. If the competition is canceled due to weather or circumstances beyond the Host's/Co-Host's control, those teams that have registered and paid will receive credit for one qualifier only if the Host/Co-Host has submitted to the DSCA Secretary within 48 hours of the scheduled event a list of those teams who have registered and paid. If a team has already received credit for 2 qualifiers or if a team chooses to compete in another qualifier in lieu of receiving credit for the canceled event, the team has a right to reimbursement from the Host/Co-Host. The Host/Co-Host must notify the DSCA Secretary within 48 hours of any reimbursement.

All qualifier competition packets must include the **DSCA 2022-2023** Rules and Guidelines, in its entirety, as provided in the Qualifier packet outline.
