- Monday & Wednesday 6:00-7:15pm Youth Age (note: gym closed Monday, May 31st – no practices)
- Monday & Wednesday 6:45-8:00pm Junior and Senior Ages
- Monday & Wednesday 8:00pm-? International Age (depending on interest)
- Tuesday & Thursday 6:30-7:30pm Mini Cheer/Tumble (age 5-9)
- Tuesday Only 5:30-6:15pm Tiny Novice Cheer/Tumble (age 3-5)
 - Age is based off the calendar year your child was born. Go to our website, select "competition team" tab, and view calendar to determine your child's cheer age.

✓ All forms & fees below are **due at first placement day**: (we cannot place you on a team till we receive ALL paperwork)

- ✓ 2021 May Tuition/First Portion of Reg Fee \$65 (prorated May tuition, remainder reg fee due June 1st)
 - "extra" tumbling classes are optional. It's an additional \$30 for all star students. Can view those spring3 class options on website now and enroll for those on May 7th. \$30 due at first placement day! (OPTIONAL not required)

▪ **Dates & times to mark in your Calendar:**

- Virtual Parents Meeting: Monday, June 7th at 9:00pm (email link closer to)
- Thursday, June 10th 7:30-8:00pm is Team Reveal Party at the gym! (athletes only)
- Monday, June 14th Youth, Junior & Seniors First Team Practices Begin: times given at reveal 6/10/21 (no mini/tiny's this week)
 - Youth, Junior & Seniors estimated summer practice day/times: Monday evening & Wednesday morning/afternoon
- Monday, June 21st Miny/Tiny Team Practices Begin: times given at reveal 6/10/21
 - Mini estimated summer practice day/times: Monday afternoon & Wednesday evening
 - Tiny estimated summer practice day/times: Wednesday evening only

➤ **Due June 1st:**

✓ Remainder of Registration Fee: \$110 (This covers music, practice wear & gym registration)

➤ **Youth, Junior & Senior Athletes Due June 14th: Mini/Tiny Due June 21st: (at first team practice)**

✓ Monthly All Star Fee: (miny/tiny \$85)

- Level 1-2: \$115. Level 3-4: \$135. Level 5 \$140 & double teamers **only** pay for highest level team.

- Optional: taking tumbling classes along with team practices. It's an additional \$30 fee for the summer session. Summer class options viewable closer too and will be due at time of enrollment. (allow 24 hour for discount to be applied)
- ✓ Shoe Information will be released this month. You will order those on your own. (shoe will be new this season)

❖ July 2021:

- **Dates & times to mark in your Calendar:**
 - Team practices remain the same in July
 - Gym closed the week of July 5th – 9th
 - **Choreography is MANDATORY: Date will be roughly End of July/Beginning of August**
 - Miny/Tiny teams will NOT have choreography till end of August
- Monthly All Star Fee & Booster Fee is **due July 1st.** (same details as above – June)
 - ✓ Booster Fee = \$85
- Choreography Fee is **due mid July** (once teams are set this amount will be determined. Mini/Tiny due end of August)
- Uniform Fee is **due mid July.** (further details closer too)

❖ August 2021:

- **Dates & times to mark in your Calendar:**
 - Team practices remain the same in August, closer to school we'll switch to evening times
 - Tiny/Minis for the school year we switch your practice day to Tuesday/Thursdays
 - Jun/Sen teams remain on Monday/Wednesdays (youth depends)
- **Due August 1st:**
 - ✓ First Competition Fee (determined once competition schedule is set.)
 - 2021-Aug, Sept, Oct, Nov. & 2022-Jan, Feb, March will be months that competition fees will be billed. This is all the competition fees are we attending broken down into monthly payments.
 - ✓ Monthly All Star Fee (same as prior month)

❖ September 2021:

 - Team practices remain the same as end of August schedule and will remain the same day/time till season end in May 2022.
 - Sunday practices may happen this season for junior/senior teams beginning in September

COMMITMENT FORM. CODE OF CONDUCT & FINANCIAL OBLIGATIONS

1. A member and a member's family must at all times be a strong representative of Champion All Stars and a positive reflection on their team.
2. Abusive behavior, bullying, lying or any other form of negative behavior by a parent or child is grounds for removal from the team.
3. No Athlete shall drink alcohol or use any form of drugs including cigarettes while in Champion attire or at a Champion All Star function. You will be subject to immediate removal.
4. Many people communicate with other parents, cheerleaders and members of other organizations through e-mail, Facebook, Twitter, and message boards. PLEASE remember, anything you say is a direct reflection on Champion.
5. If you are found communicating negatively or sending rude or inappropriate messages, you will be subject to immediate removal.
6. Upon entering and exiting Champion and while attending competitions, all athletes must be wearing appropriate attire; sports bra, uniform half tops and any other revealing attire must be covered by your warmup jacket or team shirt. This is a USASF rule that no bare midriffs are to show.
7. When you are informed of the competition schedule, dates and arrival times, it is expected that these dates and times are adhered to and all athletes are at all practices prior to all competitions.
8. All athletes are expected to be at every practice. Excessive unexcused absences will not be tolerated and are ground for removal. Please try to schedule vacations when Champion is closed.
9. I understand and agree that tuition is due the 1st of every month and that there will be a \$25.00 late charge if not paid by the 1st of every month as well as competition fees.
10. Uniforms, accessories, camps, choreography, and competition fees are due on the exact due dates given to you.
11. I understand that as a parent, I have read the Champion All Star Packet and am solely responsible for tuition, registration fees, Booster fee, uniform and accessories, choreography, competition fees and travel expenses. I'm aware all fees are Non-Refundable.
12. If I choose to leave the program after July 1st, 2021. I am subject to a \$450.00 buy-out fee plus the remainder of the tuition for the season.
