TEAM PLACEMENTS:

- Wednesday, May 7 – Wednesday, May 21. **MANDATORY Five Total Team Placement Days:** (gym closed Mon, May 26 - Mon, June 2)
- View Day and Times for your athlete to attend placements from the homepage of our website:
 - www.championcheerandtumblecenter.com
- **COMPLETE ENROLLMENT from website PRIOR to team placements!** Must be completed to participate.
 - Enrollment link closes Wednesday, May 7, 1 hour before team placements begin. Do not wait last minute.
 - o No Parent Viewing in May 2025, this includes first team practice June 9. Parent viewing will return June 11, 2025.
- ALL Forms & Tryout Fee **due Wednesday, May 7 at first placement day:** (*no participation till completed*)
 - Tryout Fee \$220 per athlete (this is nonrefundable)
 - **All five documents** + birth cert. (available to print documents or document copies available in gym)
 - 2025-2026 Release Form (all medical sections must be completed)
 - Member's Information Page
 - Commitment, Code of Conduct and Financial Obligation Form
 - Copy of Birth Certificate (if you cheered with us last season '2024-2025' this is not needed)
 - Travel and Attendance Commitment Form:
 - *Please read All Star Information packet/rules (on website only)
- Registration Fee **due Wednesday, May 21** (*no reveal email till completed*)
 - Registration Fee \$120 per athlete (this is nonrefundable)
 - **Anyone that cheered in the 2024-2025 season can deduct \$50 from this price as Florida practice wear is the practice attire which your athlete already received, making reg fee price \$70.**
 - Need to reorder any items? Email gym prior to May 22 so we're aware and reg fee price would remain \$120.
 - This covers music, one practice wear, & gym registration.

IMPORTANT FUTURE NOTE: (email us NOW if you have any conflict with mid August)

Choreography is MANDATORY: Date will be roughly mid August. As teams are getting finalized May 21, we reach out to choreographer May 21 as they fill their dates quickly for summer. So, any conflicting dates we receive after May 21 cannot be excused as Choreography is MANDATORY. (Prep, Youth, Junior, Senior age athletes)

Tiny/Mini team will NOT have Choreography till end of August/beginning of September.

TEAM REVEAL, TEAM MEET and UNIFORM SIZING:

- Monday, May 26 Teams will be revealed privately via email at 7pm. (questions can be answered Tuesday, May 27) If any tryout forms or fees are not turned in your athlete will not receive a reveal email.
- Note: gym is closed Wed, May 28 – Tues, June 3 for Gymnastic Nationals so replies to emails will be limited.

❖ **June 2025:**

- Thursday, June 5 Team Meet, Uniform and Shoe Sizing (times given in reveal email 5/26/25, evening hours)
- **Due June 5:**
 - Refundable Deposit: \$100 per athlete
 - o Failure to complete season deposit will not be refunded. Complete season, refund goes toward April 2026 tuition.
 - o Family Rate = \$200 for two kids. \$250 max for 3+ kids.
 - Monthly All Star Fee:
 - o Level 1-2: \$155. Level 3-4: \$165. Level 5: \$180 & double teamers **only** pay for highest level team.
 - o Tiny/Mini team: \$125 a month
 - o Prep team: \$145 a month

- Family rate \$250 a month
- *NEW* Extra Tumble class Information for competitive athletes: Price is included in tuition rate.
- Rec Gymnastics classes are **full** price, no max family rate applied.
- **TO AVOID 6% Processing fee in portal, complete payments cash and/or check!**
- June Refundable Deposits and June Tuition will be posted in portals on Tues, May 27
- All Star Team Practice twice a week, Summer Practice times will begin Monday, June 9 (rec tumbling also begins June 9, will not conflict)
 - Elite Team Tentative time frame for summer practices will be Monday 4:00-8:00 and Wednesday 11:00-3:00.
 - Novice Teams Tentative time frame for summer practices will be Wednesday 11:00-3:00.
 - Senior age athletes if you have any other school events in the summer, please let us know at first week of team placements so we can TRY to plan around other school involvements (if we find out after the first week, after 5/14/25 we can't alter our summer team practice schedule)
- Elite Team Shoes – order on your own, athletes must have by July 4. NEW THIS SEASON: info in reveal email
- Prep/Novice Team Shoes – order on your own, athletes must have by July 4: (same as last year) info in reveal email
- **Due June 18** (mid June)
 - Booster Fee \$170 for Elite Level athletes
 - Booster Fee \$100 for Novice/Prep Level Athletes
 - Boosters Billing is not viewable in portals as boosters is separate from champion. This means if writing a check **champion fees and booster fees cannot be on same check must be separate checks.**

 - NEW UNIFORM YEAR for Youth, Junior, Senior age athletes Uniform Deposit Due mid June (this is first portion, remainder due September/October)
 - Estimated Deposit for NEW uniform deposit: \$325 (nonrefundable) -Tiny/Mini – repeating uniforms. New size? Email us by June 11. New Athletes uniform deposit due mid June: roughly \$150 for Tiny/Mini uniform Deposit.

❖ July 2025:

- Closed June 30 – July 6
- **Due July 7**
 - Tuition Fee (same details as above – June)
 - Choreography Fee (once tryouts are completed, we'll have this price. Tiny/Mini due end of August)

FURTHER JULY INFORMATION: *Competition schedule released mid July (Tiny/Mini 6-7 competitions, local. Full Travel 8-9 competitions)

❖ August 2025:

- **Due August 4**
 - Tuition Fee (same as prior month)
 - 1st Competition Fee (determined once competition schedule is set)
 - Competition Payments will be broken down into 7 monthly payments. Competition fees will be due on the 1st in: 2025-Aug, Sept, Oct, Nov. & 2026-Jan, Feb, March (*This is all the competition fees broken down into 7 monthly payments*)

FURTHER AUGUST INFORMATION: *Team practices remain the same time, details closer to on switching to evenings for school schedule

❖ September 2025:

- **Due September 1**
 - Tuition Fee (same as prior month)
 - Competition Fee (determined once competition schedule is set)
 - **Due mid September/October**, remainder uniform balance due estimated \$325. Tiny/Mini price TBD.
 - Must have on time in order to get your uniform in time for competition season

FURTHER SEPTEMBER INFORMATION: *Team practices remain the same time, school schedule with *NEW* SUNDAY PRACTICES regularly!

COMMITMENT FORM. CODE OF CONDUCT & FINANCIAL OBLIGATIONS

1. A member and a member's family must at all times be a strong representative of Champion All Stars and a positive reflection on their team.
2. Abusive behavior, bullying, lying or any other form of negative behavior by a parent or child is grounds for removal from the team.
3. No Athlete shall drink alcohol or use any form of drugs including cigarettes while in Champion attire or at a Champion All Star function. You will be subject to immediate removal.
4. Many people communicate with other parents, cheerleaders and members of other organizations through e-mail, Facebook, etc. PLEASE remember, anything you say is a direct reflection on Champion.
5. If you are found communicating negatively or sending rude or inappropriate messages, you will be subject to immediate removal.
6. Upon entering and exiting Champion and while attending competitions, all athletes must be wearing appropriate attire; sports bra, uniform half tops and any other revealing attire must be covered by your warmup jacket or team shirt. This is a competition wide rule that no bare midriffs are to show.
7. When you are informed of the competition schedule, dates and arrival times, it is expected that these dates and times are adhered to, and all athletes are at all practices prior to all competitions. (2 weeks prior or subject to not compete at event)
8. All athletes are expected to be at every practice. Excessive unexcused absences will not be tolerated and are ground for removal. Please try to schedule vacations when Champion is closed.
9. I understand and agree that tuition and competition fees are due the 1st of every month and/or there will be a \$25.00 late fee if not paid by the 1st of every month. (\$25 competition fee AND \$25 tuition late fee, resulting in \$50 late fee.)
10. Uniforms, accessories, camps, choreography, and competition fees are due on the exact due dates given to you.
11. I understand that as a parent, I have read the Champion All Star Packet and am solely responsible for tuition, registration fees, Booster fee, uniform and accessories, choreography, competition fees and travel expenses. I'm aware all fees are Non-Refundable.
12. If I choose to leave the program after May 25, 2025. I will *not* receive the refundable deposit and I am subject to complete an additional buyout fee of \$200.00. (As stated above if refundable deposit is not completed then buyout is \$300 total)

#2 I understand competition fees are nonrefundable, if athlete gets selected as an alternate prior to a competition due to not attending practice(s) two weeks before a competition, then my athlete could be subject to be removed from his/her team for that event. However, will be expected to be at event to support their team:

#3 I understand it's my responsibility to notify the gym with a TWO week notice if ANY scheduling conflicts arise for a scheduled practice date. (family events, school graded activities, and/or other sports.)

*If your schedule is busy during school year, please understand a rec local team might be the best option. If you're a returning athlete and had multiple absences, please understand your team placement could reflect the number of absences from last season for your athletes team placement for the new season.

*If your concerned this pertains to you, please email us so we can schedule a meeting to discuss in further detail, prior to team reveal! That way we can discuss if this conflict can be resolved for the 2025-2026 season.
