



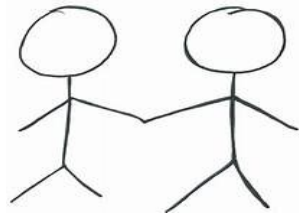

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT (“AGREEMENT”)

In consideration of participating in the **Activity, including but not limited to cheerleading classes, tumbling classes, stunt classes, dance classes, private lessons, competitions, exercise classes, and any other activity taking place at or through Winnersville Elite Cheer and Dance**, I represent that I understand the nature of this Activity and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the Activity.

I fully understand that this Activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the “releasees” named below, and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the Activity.

I hereby, discharge, and covenant not to sue **WE Can, Inc. d/b/a Winnersville Elite Cheer and Dance**, its respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the “RELEASEES” herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the “releasees” or otherwise, including negligent rescue operations, and I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the “releasees”, I will indemnify, save, and hold harmless each of the “releasees” from any loss, liability, damage, or cost which any may incur as a result of such claim.

I have read this **RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.

PARENTAL CONSENT

AND I, the minor’s parent and/or legal guardian, understand the nature of the above referenced activities and the minor’s experience and capabilities, or lack thereof, and believe the minor to be qualified to participate in such activity. I hereby release, discharge, covenant not to sue and **AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLLESS** each of the “releasees” from all liability, claims, demands, losses, or damages on the minor’s account caused or alleged to have been caused in whole or in part by the negligence of the “releasees” or otherwise, including negligent rescue operations, and further agree that it, despite this release, I, the minor, or anyone on the minor’s behalf makes a claim against any of the above “releasees”, I **WILL INDEMNIFY, SAVE AND HOLD HARMLESS** each of the “releasees” from any litigation expenses, attorney fees, loss liability, damages, or costs any “releasee” may incur as the result of any such claim.

MEDICAL RELEASE

I grant “releasees” permission to provide medical treatment for any injuries incurred during participation in the Activity, and do hereby release and hold harmless each of the “releasees” from any claim, loss, liability, damage, or cost arising from such treatment.

PHOTO RELEASE

I grant “releasees” permission to use photographs taken during participation in the Activity, in a manner permitted by law, in printed publications, including, but not limited to, advertisements, both paper and electronic, event flyers, and our website without notification or compensation of any kind.
