

Starlitz Xpress Cheer TUITION AGREEMENT

Please initial and complete document This Agreement Form is for _____,
and effective JUNE 1st, 2019.

- _____ 1. No Family will be allowed to register if they have an outstanding balance from a previous year/season.
- _____ 2. A deposit of \$185 (including registration) is due at the time of registration. The registration deposit reserves your athlete's spot on a team and contributes to tuition fees.
- _____ 3. Monthly training tuition \ will be due on the 1st of each month. If payment is over 3 days late, a \$30 late fee will be charged to your account. If your payment is over 5 days late, your athlete will not be permitted to participate in any Starlitz Xpress practices, classes or activities.
- _____ 4. Being part of a Starlitz Xpress Cheer team is a yearly commitment; payment is made monthly to cover the season's tuition. The team commitment is from June-May.
- _____ 5. I understand that my first monthly tuition payment will be due by no later than June 3rd and my last tuition payment will be made on May 3rd.
- _____ 6. I agree to pay all cheer fees. I agree to make 11 payments to Starlitz Xpress fees from June 1st through May 1st. I will be responsible for out of budget costs and any and all costs associated with Nationals if my child's team receives a bid.
- _____ 7. I agree to pay by credit card, online, or check on the 1st of each month.
- _____ 8. A Service Fee of \$30.00 will be assessed for NSF transactions (non-sufficient funds) or payments that are received after the 3rd; if your account is not up to date in 5 days, your athlete will not be permitted at practice.
- _____ 9. If an athlete/family decides to leave the Starlitz Xpress Cheer program or is suspended or dismissed, written notice is required. Tuition payments within 30 days of written notice are expected to be paid by the family. All Cheer fees for the season will need to be paid in full, regardless of reason for leaving the program.
- _____ 10. We/I understand that Starlitz Xpress does not offer any refunds. Including but not limited to, tuition payments, Cheer fees, etc.
- _____ 11. We/I have read, understand and will abide by Starlitz Xpress Cheer Tuition Agreement, as well as all updates and revisions.
