Team Evaluations Checklist

- Become a gym member on the website on the parent portal.
- Pay gym registration fee (\$60) and tryout fee (\$55 early bird, \$65 on time) in the gym portal.
- Select your age group for evaluation under tryouts.
- Turn in your signature pages from your printed contract on your first evaluation day.
- Attend stunt evaluations by appointment on May 17 (2pm-6pm by level)
- Come to team reveal on May 18, 2026 @6:00pm

To evaluate for a team, parents should register on the gym website providing their basic contact information before submitting the signature pages. All payments must be submitted through the parent portal. Gym registration fees must be current, and all gym accounts must be in good standing with a zero balance prior to participating in team evaluations. Tryout fees and gym registration fees are non-refundable. Athletes will not be allowed to evaluate a team under any circumstances without signature pages, tryout fee paid online, and gym registration fee current prior to evaluation.

Athletes' parents will be notified on Monday May 18, 2026, at 6:00pm of their child's projected team placement at the Team Reveal at the Morgan Road location as well as via email. Team rosters are not released to parents, but team members will meet at the team reveal as well as at their first scheduled team practice. Team placements are fluid and athletes may be changed after team placements are made initially based on age, skill level, role in the routine, routine score maximization, overall perfection of level appropriate skills, and changes in the scoring grid or age grid. Attendance is critical to show improvements and to ensure proper team placement.

Non-travel teams can compete as Prep or Novice in any age group. Travel teams can compete as elite or limited elite teams in any age group.

Important Dates

- Bama All Star Stunt Clinic - June 6, 2026
- Routine Choreography Weekends
 - Senior Elite August 7-9, 2026
 - Junior/Youth Elite August 21-23, 2026
 - Prep/Novice August 28-30, 2026

Choreography Dates are tentative. Weekends may be changed as choreographer's schedules may change. Plan to be in town for all weekends in August to ensure that you do not miss choreography.

Practices and Attendance

Attendance is a high priority for a team's success. Spending time working together on their skills with all team members present greatly increases the team's success. Athletes who fail to comply with or abuse the attendance policy jeopardize their team placement. Team attendance is divided into two sections: summer training and competition season.

Practice Dress Code

- Assigned practice wear and cheer shoes are to be worn at every team practice. Athletes will be assigned age-appropriate conditioning for each piece of missing practice wear (bow, top shorts, shoes).
- Hair must be up and out of the athlete's face in a high ponytail or bun for practice. Athletes with protective styles should select styles that can be placed in a high ponytail or bun that will remain secure throughout the entire practice.
- Hair must not hang longer than mid-back. If an athlete has hair that is longer than the acceptable length, she/he must braid, curl or put their hair in a bun that will not fall out for safety reasons.
- No acrylic nails may be worn, including press on nails.
- Jewelry is prohibited without exception at practice including but not limited to rings, necklaces, anklets, ear/nose/belly/tongue rings, bracelets, or any other items. An athlete wearing jewelry will be required to remove the item before they are allowed to take the floor for practice. Bama All Starz is not responsible for lost or stolen jewelry.
- All female athletes are required to wear sports bras and undergarments under their practice wear regardless of age.
- Male athletes must wear compression shorts under their practice shorts.

Summer Practices

Athletes have one practice a week as a team. Between the team formation/first practice and August 1 team members are required to attend 6 summer practices to confirm their spot in the routine choreography. If there will be planned absences, parents must provide those dates with team coaches at the first practice. The gym will be closed for the 4th of July holiday and those dates do not count against an athlete's attendance. Team practices will be scheduled for one day a week Monday-Thursday and are the same day and time each week.

Choreography

Team choreography weekends are the times that choreographers come to teach the routines our teams will compete for the season. This time is mandatory and will be set once the team's form. Please do not schedule vacations, last-minute trips to the beach, or any other weekend activities in August when we have scheduled choreography blocks.

Competition Season

Competition Season: August until the end of competition season, an athlete has 3 allowed unexcused absences. All elite teams practice once on Sunday plus one weekday practice. Prep and novice teams will have one weekly practice. Practice times vary from 1.5 hours to 3 hours depending on the team. The cost of the team does not fluctuate if team practices are added or cancelled.

Attendance Policy

Summer session = athletes must attend minimum 6 of 8 team practices to maintain athletes' place in routine choreography. August to April 3 unexcused absences allowed.

- Athlete absences should be reported to your team coach as soon as possible in the GroupMe in the Absence Chat. Failure to report your child's absence in a timely fashion will result in an unexcused absence recorded and a \$25 fee added to your child's account.
- Arriving to practice 15 minutes late or asking to leave more than 15 minutes early will result in a half absence recorded for the athlete. Two half absences will count as one unexcused absence.
- Communicating regarding an absence does not constitute an excused absence being granted.
- Planned absences, including doctor's appointments and family commitments should be communicated to the coach no less than 2 weeks prior to the absence or the absence will be unexcused without exception.
- Unplanned absences (emergencies) should be reported to the coach as soon as possible.
- Excessive excused absences will result in a parent meeting to determine if team role change, team designation changed, alternate status on the team, or team dismissal is appropriate.

Excused Absences

Excused absences include school functions that result in a grade, documented diagnosis of a contagious illness that prevents your child from coming to practice (doctors note required).

Unexcused Absences

Unexcused absences include but are not limited to homework, study groups, weddings, trips, church activities, jobs, or punishments from parents. Athletes are responsible for catching up on missed material at practice including tumbling and jump reps and stunts.

Tardy Policy

- First tardy: Warning, with Groupme/text sent to parent
- Second tardy: Parent phone call followed up with email
- **Third tardy and subsequent tardies: \$25 fee added to your child's account**

Unexcused Absence Protocol

- **First Absence:** Coach contacts athletes parent, notifies all star director
- **Second Absence:** Athlete role in the routine reduced with all star director, All Star Director contacts parent
- **Third Absence:** Parent/athlete meeting with All Star Director regarding absences
- **Additional absence:** Athlete removed from team, athlete season balance is due

Tardies and unexcused absences to practices will result in consequences including but not limited to conditioning exercises to make up for lost practice time.

Competition Week

Absences during the seven (7) days prior to competition are not allowed. **Missing practice during the week of competition will result in a \$50 fee added to the athletes account to accommodate for the costs of coaches coming in for additional practice.** Missing practice may result in an athlete being placed as an alternate in the upcoming routine.

Missing a competition for a scheduled event (wedding, family vacation, sickness, school field trip, other conflicts) with advanced notice will result in a \$500 fee assessed to your child's account. Missing a competition without a week's notice can result in a fee equal to 100% of your athletes entry fee for the competition and/or termination from the program with the season balance due.

Gym Closure Dates

Both gym locations are closed on the following dates:

- Memorial Day - May 25, 2026
- Independence Day Break - July 1-5, 2026
- Labor Day Break - September 4-7, 2026
- Thanksgiving Break - November 22-28, 2026
- Christmas Break - December 21-31, 2026
- New Years Day - January 1, 2027
- Spring Break - March 21-27, 2027
- Easter - March 28, 2027

The gym will also cancel activities due to dangerous weather conditions, staff training, competitions, performances, clinics, or other gym events.

School Cheerleading

Bama All Starz works diligently to schedule team practices for athletes on school cheer teams with minimal conflicts between school cheer and all star cheer. School cheerleaders will have limited excused absences for school cheer activities. Parents should provide Bama All Starz with the school cheer schedule as soon as it becomes available, and reminder emails should be sent to all star coaches regarding school cheer absences weekly. Absences with less than 24 hours notice must be followed up with a screenshot or forwarded message from the school coach confirming the rescheduled event; otherwise the absence will not be excused.

Injuries and Unexpected Emergencies

If an athlete is sick (but not contagious) or has an injury, they are expected to attend team practice. An athlete may attend and have limited participation (mark throughs only, stunts only, tumbling only, alternating reps = reduced participation) and still gain valuable time learning changes made during practice that may impact their part of the routine.

An athlete with a fever may be contagious and should refrain from attending practice. An excused absence will be given for fever documentation or a doctor's note.

If an injury occurs during practice, a coach should be notified immediately. The athlete cannot return to full participation until a doctor's note clearing the athlete to return to full activity is received - no exceptions. Athletes should still attend practice during their recovery period unless the doctor advises otherwise.

An injured athlete is excused from participating but not excused from practice attendance unless a doctor recommends an athlete to stay at home. An excused absence is given if a doctor states stating an athlete must refrain from attending practice due to injury.

Parents are responsible for paying all All Star Fees while their child is recovering from injury. An alternate athlete may be placed in the athlete's position in the routine during this time. Once the athlete is cleared by the doctor to resume practice, it is at the coaches discretion (not the parents) to determine when the athlete is ready to resume their role in the routine. Athletes will progress through a return to activity checklist before they are allowed to return to full routine participation. Missed classes due to injury are not prorated. If an athlete is not well enough to fully participate in team practice, they must not participate in tumbling classes until they are cleared to engage in both.

Team Placements

Team Placements

Team Placements are made based on each athlete's age, skills, maturity, role in the routine, experience, and what will make the team most competitive. The team placements are in the best interest of the program.

Best Interest of the Program

Athletes are placed on teams based on the best interest of the program and to maximize the scoring potential of the team. It is the athletes responsibility to maintain their skill set throughout the season and develop new skills through tumbling classes and team practices. Athletes must also be familiar with their role in the routine (e.g. base, backspot, flyer, front spot, tumbler) and the specific routine skills (stunts, jumps, tumbling, dance, baskets, etc.). Occasionally, an athlete may be moved to a different team or asked to serve as an alternate for an additional routine. Such moves are made in the best interest of the program and the athlete's skills. These moves are not punitive and the decisions are made after careful consideration and evaluation of both teams, in collaboration with the All Star Director.

Declining Team Placement

An athlete becomes an official member of the Bama All Star program upon trying out for a team. After tryouts, the athlete has until 6:30pm two days after team placements are released to decline their placement in writing via email or letter to the all star director. After this time, the contract is binding and the agreement stands as written. Team placements may change until routine choreography is finalized, and the teams can be formed, disbanded, or combined after trials at the owner's discretion and the best interests of the program.

Coaches Decisions

Bama All Starz parents and athletes understand that coaches and staff had the final decision regarding an athlete's team placement, roles in the routine, and positions in formations at any point during the season. Coaches may assign athletes as alternates in a routine they were previously part of due to attendance or just disciplinary issues before removal from the team. Any changes to the routine are made in the best interest of the team and the routine teams may also be formed, disbanded, or combined after tryouts at the gym at the owner's discretion, based on the best interests of the program.

Competitions: Schedule, Travel, Dress Code

Competition Costs

Competition costs are included in the inclusive fee for the cheer season. However, bids to the D2 Summit or The One may incur additional fees beyond the deposit included in the season's inclusive fee.

Competition Information

The competition schedule along with a season calendar of events will be provided to parents and athletes. We will adhere to this schedule unless extenuating circumstances require changes. When registering for competitions, we do not have control over the teams we compete against or the number of teams in each competitive group. We will not entertain questions regarding our competitors or why other programs may not be attending the event. Additionally, parents are not permitted to enter the warm up area for any reason at competition.

For each competition, we will provide details of the team's arrival times, meeting with coaches, competition time, release to parents when applicable, and awards. These times will be available by Thursday of competition week, though they are dependent on the event producers finalizing the competition schedule and sending the information to our program in a timely fashion.

Parent Travel Obligations

Parents are responsible for their child's behavior and activities at competitions. They are also responsible for transporting their child to the competition, providing lodging, meals, and handling any other activities related to the competition day aside from participation on the competition floor. If a parent is unable to attend a competition, they should arrange for their child to be cared for by a responsible adult or another Bama All Starz parent who will take responsibility for their athlete. Bama All Starz parents understand that some competitions may take place outside of the Birmingham area. Parents should be aware that competitions are not vacations, and the athletes focus should primarily be on Bama All Starz. For out of town events, parents must adhere to stay to play guidelines when required for booking hotels. Parents must arrive in the competition city on Friday and depart after the event concludes including the team's award ceremony. Competition schedules will be provided the week of the event or as given by the event producer.

Bama All Starz is not responsible for any travel disruptions caused by event rescheduling or changes. We recommend that parents purchase refundable or transferable travel options. Many parents choose to drive to competitions and do not require flights.

Competition Dress Code

- Athletes arrive at the competition dressed to compete, with full makeup and competition hair
- Athletes are dressed in full uniform or in appropriate athletic wear.
 - Athletes can wear jerseys, jogging suits, or t-shirts over their uniforms.
 - Competition cheer shoes must be worn.
 - Slippers, Uggs, flip flops, or pajama pants are not permitted.
- Hair must be pulled up in a high ponytail or bun, with no loose hair or loose braids on the front, back, or sides.
 - Protective styles must be able to be pulled up into a high ponytail or bun.
 - All hair must be up and out of the athletes face and off their neck.
- Makeup must be from our makeup kit, using a natural look, including blush, mascara, red lip stain, and smokey/earthtone eyeshadow.
 - No glitter allowed.
 - Lashes are required for Senior teams.
- Fingernails must be short. When looking at the palm, nails must not extend past finger tips.

- No acrylic nails allowed.
- Polish is allowed with french tip, clear, or Bama All Starz colors.
- White no show socks only.
- No jewelry is allowed, including any piercings, rings, necklaces, or bracelets.
- Male athletes should be neatly shaven for competition.

Communication

Bama All Starz communicates important information to parents and athletes via email, GroupMe, Facebook, flyers, and the gym website. Billing is managed through our website. Parents are responsible for staying informed by regularly checking these communication channels.

Behavior

Bama All Starz expects all athletes and parents to uphold a high standard of behavior, both in and outside the gym. Respect for coaches, teammates, other parents, judges, officials, and spectators is essential. Disrespectful behavior, including drama or inappropriate actions from parents, athletes, or family members - such as fighting, bullying, arguing in public or in the gym, or unsportsmanlike conduct will not be tolerated and will result in immediate removal from the team, with no exceptions. All Bama All Starz members are expected to demonstrate good sportsmanship before, during, and after competitions. We treat athletes and coaches from opposing teams with respect and remain humble in success and gracious in defeat. Our focus is on fostering a positive, supportive, and respectful environment for all involved.

Cool Down for 24 Hours

Parents are required to schedule an appointment with the coaches or staff to discuss any athlete concerns, and this should be done no earlier than twenty four hours after the incident. Concerns will not be addressed during competitions or in public settings, allowing for a calm and productive conversation. This approach ensures that emotions do not dominate the discussion and that all parties are addressed appropriately. Additionally, athletes and parents must refrain from posting negative messages about cheer on social media, including limited to private stories, spam accounts or direct messages. Failure to comply with the cool down policy can result in removal from the program with season balance due.

Bullying and Abuse

Bama All Starz does not condone bullying or abuse of any kind, whether directed at athletes, parents or coaches. We are committed to maintaining a safe and respectful environment for all involved. If any instances of bullying or abuse occur, we will take immediate action to investigate and address the situation. This may include meetings with the individuals involved, implementing disciplinary actions as necessary, and providing resources for conflict resolution. Our priority is to ensure a positive supportive atmosphere for every member of the Bama All Starz community.

Social Media Policy

Parents and athletes understand that social media posts in messages directly reflect not only on the gym but also on the coaches, staff, and themselves. Athletes and parents are prohibited from posting inappropriate messages on social media including but not limited to post on stories, news feeds, or

direct messages (Example - Facebook, Twitter, Instagram, spam accounts, group chats and private messaging). Inappropriate messages should be reported to the all star director. Such messages can result in disciplinary action, including potential dismissal from the program.

Unauthorized posting of videos included on Facebook, YouTube or any other public website is allowed until the season has ended. We encourage families and supporters to respect this policy as well. Photos taken during the season are acceptable.

The only official team group chats for team communication will be created by the coaches, vehicle me or Instagram for athletes to share videos with the coaches. No other team base Jim will be sponsored by the gym. No additional team based group chat should be created in an effort to limit drama that hinders our program.

Athlete Disciplinary Actions

If an athlete does not comply with the rules of the handbook, the following actions will be taken:

1st offense: coach/athlete meeting

2nd offense: Parent conference with the athlete

3rd offense: removal from the team or program

Financial Obligations

All-Inclusive All Star Fees for 2026-2027 Season

Tiny - June-August \$100/month, September-March \$250/month (\$2550 total)

Prep - \$300/month for 10 months, payments June to March (\$3000 total)

Limited Elite - \$400/month for 11 months, payments June to April (\$4400 total)

Elite - \$450/month for 11 months, payments June to April (\$4950)

Super Senior Elite - \$225/month for 11 months + uniform fee (if team is wearing a new uniform), payments June to April (\$2475-\$3000 total depending on uniform fee)

Crossover fee - \$950 in addition to your Bama All Star Fees

All Bama All Star teams receive these benefits as a part of their all star fee

- Weekly team practice (1 per week for June-July for all teams, August forward twice a week for elite and limited elite, once a week for prep/novice)
- Weekly tumbling class (elite teams receive unlimited in June-July)
- Open Gym
- Routine choreography and competition music
- Competition Fees (plus end of season event deposit for elite and limited elite teams)
- Coaches Fees and travel expenses
- New competition uniform and bow
- Practice uniform (2 for elite and limited elite)
- End of Season celebration, recognition, and squad awards

Bama All Star Fee does not include these required items:

- Nfinity cheer shoes (order in summer \$125-\$160)
- Nfinity backpack (order in summer \$130)
- Makeup kit \$45 (order in September)
- USASF membership (register/renew before team choreography in August)
- Athlete transportation, lodging, or travel expenses
- Meals or spectator fees for parents or guests
- Post season bid events additional fees above deposit
- Warmups (optional) approximately \$140, order in September

Exceptions

The Bama All Star fee is non-prorated and will not be adjusted for holidays, gym closures, weeks without squad practices, missed competitions, injuries that still allow participation in squad activities, voluntary non-participation, dismissal from the program, or any other circumstances unless prior written approval is given by Bama All Starz. Both the parent and athlete acknowledge that no refunds will be issued for missed tumbling classes, mandatory squad practices, scheduled special events (such as choreography camps or picture days), or competitions.

Pandemic/Acts of God

In the event of a pandemic, we will implement safety protocols to ensure the well-being of all athletes. Parents and athletes understand that these protocols may include social distancing, limiting the number of athletes in the gym, closing parent/public areas, canceling practices, postponing or canceling competitions, and temporarily closing facilities as required by public health guidelines. Bama All Star fees will not be prorated during this time, and reimbursements or compensation are not guaranteed due to scheduling constraints and other factors, including competition season extensions, cancellations, or actions mandated by USASF and participating competition organizations.

End of the Season Events: Summit, The One Prime Finals

A bid deposit is included in your child's Bama All Star fee. Coach fees are not included in this deposit and will be calculated based on the actual cost of coaches attending the event. These fees will be added to the athlete's statement once the end of season event is selected.

The athlete's season does not end until after the bid event has been completed, and athletes are required to attend bid events with their respective teams. The last practices of the season will occur during the week leading up to the bid event, and parents should avoid making travel arrangements that conflict with practices that week. Additional fees for bid events have ranged from \$75 to \$250 per athlete in previous seasons for The One Prime Finals, and from \$100 to \$500 for D2 Summit, in addition to the deposit included in the Bama All Star fee.

Each team will collect bids throughout the season. Coaches will determine which end-of-season event the team will participate in, whether it is D2 Summit or The One Prime Finals. **Attendance at these events is mandatory for all athletes and cannot be negotiated.**

Copyright Notice

Official Bama All Starz merchandise is available for purchase in the gym pro shop. This includes team names, any likeness of the logo, affiliation, or program, which cannot be used without the permission of the owner, Tristan Twyman.

If a team wishes to purchase an item for an entire team, it must be approved by the owner and made through one of our approved vendors using the Bama All Starz logo. All items must be approved by Tristan Twyman before ordering. Items may be personalized using our gym colors for lettering. The purchase and use of any apparel or logo is at the discretion of the owner, Tristan Twyman.

Monthly Payments/Payment Schedule

Option 1:

The season balance may be paid in monthly installments, with the first payment due on June 1, 2026. Payments will be auto-drafted on the 1st of each month, with a season balance paid in full by April 1, 2027. **A credit card must be on file on your account at all times throughout the season, and auto-draft must be activated for monthly payments.** A late fee of \$25.00 will be assessed if payment is not received by the 4th of the month.

Option 2:

The season balance may be paid in full on June 1, 2026. Payments can be made by cash, check, or credit card. *Any remaining balances at the end of the season will incur a monthly late fee starting April 4, 2027. Athletes with overdue accounts during the season may be asked to sit out of practice until their account is current.*

There are no refunds for athletes who choose to leave the program or quit a team. The financial commitment is for the entire competition year. Athletes who resign from a team will still be responsible for the remaining balance, with no exceptions. Additionally, athletes who resign may be subject to a re-choreography fee of up to \$1,500, in addition to any outstanding balance.

Discounts: All discounts will be applied to the final month's payment unless the all star bill is paid in full.

Referral Discount

- \$100 referral credit to your athlete's account for each new athlete who joins the prep or novice program and maintains their position on the team.
- \$150 referral credit to your athlete's account for each new athlete who joins the elite or limited elite program and maintains their position on the team.

Legacy Discount

- \$100 account credit for athletes entering year 3 or 4 on a Bama All Starz team
- \$250 account credit for athletes entering year 5, 6, 7, 8, or 9 on a Bama All Starz team
- \$1000 account credit for athletes entering year 10 and beyond on a Bama All Starz team

Payment Process

Web Registration and Payment Authorization

All athletes **must** be registered in our online portal prior to tryouts. Registration fees and tryout fees **must** be paid in advance of tryouts as well as paperwork turned in. A credit/debit card **is required** to be on file in order to register.

Each month beginning June 1 monthly payments are to be made on the 1st of the month. Declined payments must be cleared on or before the 4th of the month. On the 5th of the month a late fee of \$25 will be assessed to all late payments.

Contractual Obligations

Upon submitting the contract, it becomes effective immediately, and all financial obligations are agreed upon by the parties signing the contract. Families have the right to contact the all star director after team placements but following the reveal of team placements families have until 6:30pm two days later (Wednesday, May 20, 2026 at 6:30pm) to decline their placement. After this time the contract is binding, and the agreement stands as outlined. If an athlete quits or is dismissed from the team after 6:31pm on May 20, 2026, the full contract amount remains due, including any applicable interest and collection fees, regardless of whether the athlete competes. If an athlete resigns after the deadline but before receiving their apparel, no refund will be issued for the cost of the apparel.
