



## DEA Payment Agreement Options – SUMMIT TEAM

\_\_\_\_\_ **Option #1 Pay in Full:** This option allows the parent to fulfill the financial obligation in full and receive a 5% discount. This discount does not apply to monthly tuition. Tuition fees will continue to be drafted monthly.

\_\_\_\_\_ **Option #2 Monthly Payments RETURNING ATHLETE – STANDARD OPTION:** This option is designed for those who desire to make monthly payments, beginning in May 15, 2019 and ending February 15, 2020. With this option an initial payment of \$395.00 is made at the parent meeting the week of Tryouts, followed by 10 consecutive monthly payments of \$167.00. This payment is in addition to your monthly tuition, yet can be drafted on separate days. (ex.: Tuition on the 1<sup>st</sup> and all-star payment plan on the 15<sup>th</sup>)

\_\_\_\_\_ **Option #3 Monthly Payments SUMMIT OPTION ½ DEPOSIT:** This option is designed for those who desire to make monthly payments, beginning in May 15, 2019 and ending February 15, 2020. **With this option an initial payment of \$197.50 or half the deposit amount of \$395.00 is due at the parent meeting, the week of Tryouts. The balance of the deposit amount (\$197.50) will be split into 2 payments, \$98.75 each, due with June 1<sup>st</sup> tuition and June 15<sup>th</sup> all-star fees payment,** followed by 10 consecutive monthly payments of \$167.00. This payment is in addition to your monthly tuition, yet can be drafted on separate days. (ex.: Tuition on the 1<sup>st</sup> and all-star payment plan on the 15<sup>th</sup>)

\* By turning in the signed DEA Payment Agreement Form at tryouts, DEA will process the initial down payment by April 25, 2019.

\*\*I agree to the initialed payment option for all expenses above and beyond normal monthly tuition costs. I understand failure to follow the agreement can result in removal from the DEA All-Star Cheer Program. There are NO refunds for any reason (removal from the DEA All-Star Cheer Program, quitting, injury etc) or items returned.
