*Please read this carefully as it is very important regarding proper registration in any SSGA training program.*

The following are the guidelines for SSGA tuition and services payment options.

**Paid in Full Option** – If you choose this option, please note that full payment is due at time of registration. If the amount is not paid in full the EFT form must be completed. Please understand that there are no exceptions.

**Monthly EFT Option** – This is the only installment option available at SSGA. The EFT form must be complete and signed with a voided check at the time of registration.

**Credit Card on file for EFT accounts:** All EFT accounts must provide a credit card as a backup to the EFT/ACH checking account on file. This is only processed in the event the EFT/ACH is not paid to SSGA for Non-Sufficient Funds or delinquent payments. Please see attached form to be completed at registration.

To expedite the registration process, please have all forms complete and attach a voided check to the signed EFT form.

SSGA Monthly EFT payments are charged to your account on the 1st business day of each month, beginning in October with the last EFT debit processed in June.

September tuition payment and a \$25 registration fee are due at time of registration. If you choose the paid in full option and we have not received full payment, the EFT debits will begin as listed above.

I AM VOLUNTARILY PARTICIPATING IN THE ATHLETIC TRAINING PROGRAM(S) AND INSTRUCTION OFFERED BY SSGA WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY OR DEATH. I, for myself, my heirs, successors, executors, and assigns, hereby KNOWINGLY AND INTENTIONALLY WAIVE, RELEASE, AND HOLD HARMLESS SSGA, its members, directors, officers, agents, employees, instructors, coaches and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorney’s fees) arising directly or indirectly from my participation in any athletic training program or instruction offered by SSGA or arising while I am under the instruction, supervision, and/or control of SSGA, regardless of whether the damage, loss, injury, paralysis, or death results from the negligence of SSGA or from some other cause.
