

# Financial Agreement Form

1. The foregoing is a contractual agreement between \_\_\_\_\_ (client) and Infinity and any and all agreements written herein constitute the entire agreement between the parties
2. The client agrees and understand that this Agreement remains in effect as long as their son/ daughter is enrolled for classes at Infinity .
3. The client agrees and understands that Infinity must be notified via email to info@ictohio.com prior to the 15th of each month if they will not continue enrollment. Any notice received after the fifteenth of the month will be canceled the following month.
4. The parties agree that the agreement can be terminated by mutual agreement in writing provided 30 days in advance. Infinity could also remove your son/daughter from the program with written notice.
5. **I understand a credit/debit card can be held on file and charged on the 1st of each month.** I understand that if my card is declined or my bill is not paid by the 10th of each month I will receive a 10% late fee for my total outstanding balance.
6. The client hereby authorizes Infinity to obtain payment through the credit card on file which the client has provided for the sole purpose of Infinity processing the card to obtain payment on a monthly basis for the tuition/competition payment(s).
7. The parties agree that the monthly tuition payment is due the 1st day of each month. The parties further agree that a late charge of 10% will issue for each and every monthly payment not received by Infinity prior to the 10th day of each month.
8. I understand that tuition is based on a monthly basis. We DO NOT pro-rate for holidays, gym closures (planned or unplanned), missed classes or vacations.
9. **I understand that if I do not choose to have a card on file my bill is due by the 1st of each month, and my rate for all classes will be higher. Initial here** \_\_\_\_\_
10. I understand a \$35 NSF fee will be applied for all returned checks or declined credit cards.
11. I understand that past due accounts carrying a balance for more than 30 days, my son/daughter will be suspended from practices and competitions, and merchandise will be withheld until the balance is paid in full.
12. I understand Infinity has a NO REFUND policy for items purchased, tuition, choreography or camp fees, missed classes and competitions fees paid.
13. I understand that my account must be current (account must have a zero balance by the 10th of every month) Infinity reserves the right to seek return or not to provide a uniform or merchandise or services for any athlete whose account is not paid up to date by the 10th of every month.

**Violation of this agreement:** If suit or action is instituted, or any appeal taken from, in connection with any controversy arising out of this agreement, the prevailing party shall be entitled to recover, in addition to costs, such as lump sum as the court may determine reasonable as attorney or collection fees. This agreement and all transactions there under, and all rights of the parties hereto, shall be governed as to validity, construction and all other respects by the State of Ohio. In the event of any action commenced by either party against the other, such action shall be commenced and tried in a court of competent jurisdiction in the County of Lorain, State of Ohio.

- This agreement, although drawn by Infinity , has been carefully read by me, and shall be construed fairly and reasonably, and not more strictly against one party than against the other party hereto. As a parent/participant, I understand that I am fully responsible for paying all expenses incurred by myself or my child and authorize Infinity to charge the account listed above if my account falls 5 days past due.
- Any cheerleader, who makes the Infinity competitive team, has a financial obligation to Infinity regardless of their team position. As a parent/participant, I am obligated to pay tuition and competition fees during this entire season. Tuition and competition fees are non-negotiable. I must fully commit to the Infinity Athletics program. By signing the financial agreement form, I am giving my FULL commitment to Infinity and the financial obligation that comes with participating in its competitive program for the season stated above.
- The validity or un-enforceability of any provision of this agreement shall not affect the validity or enforceability of the remaining provisions. This agreement shall not be modified except by written agreement executed by both parties.
