

# EAST COAST XTREME CHEER BOOSTER CLUB 2017-2018 PARTICIPATION AGREEMENT

In consideration of my application for membership in the EAST COAST XTREME CHEER BOOSTER CLUB, I understand and agree to abide by the following requirements and conditions for membership:

1. Parents and legal guardians of EAST COAST XTREME CHEER athletes and other associated or related individuals interested in the sole purpose of supporting and promoting the EAST COAST XTREME CHEER cheerleading program are eligible for membership in the EAST COAST XTREME CHEER BOOSTER CLUB.
2. Memberships shall be offered as an Athlete Membership or Supporting Membership. All applicants shall complete an accurate EAST COAST XTREME CHEER BOOSTER AGREEMENT (per athlete), and pay the membership dues (per athlete) of thirty dollars (\$30.00). Membership dues shall not be pro-rated regardless of the date of the applicant. EAST COAST XTREME CHEER athletes in good standing are those who have signed a Financial Agreement with EAST COAST XTREME CHEER.
  - a. Athlete Membership and Supporting Membership requires:
    - i. Submission of the application for membership
    - ii. Submission of the participation agreement
    - iii. Payment for membership \$30.00 per athlete
3. Active Members are family members or individual members who have paid the annual membership dues of thirty dollars (\$30.00) per athlete, have signed and submitted the EAST COAST XTREME CHEER BOOSTER CLUB participation agreement. Supported and participated in fundraising events, effort and projects. Active members receive one (1) vote at the General Membership Meetings.
4. Any Booster Club (Athlete) member or Supporting Booster Club Member who chooses to prematurely terminate their contractual obligation or is terminated from EAST COAST XTREME CHEER shall forfeit all membership dues, credits, donations and/or allocations of Distribution Funds raised by the Booster Club. Those funds will be distributed equally amongst all active members.
5. Any Booster Club member or Supporting Booster Club member, who is terminated, expelled or who forfeits their membership in the EAST COAST XTREME CHEER BOOSTER CLUB will forfeit all membership dues, credits, donations and/or allocation of Distribution Funds raised by the Booster Club. Those funds will be distributed equally amongst all active members.

6. All Booster Club (Athlete) members and Supporting Members will be required to conduct themselves appropriately and in a manner that will reflect positively on the EAST COAST XTREME BOOSTER CLUB AND EAST COAST XTREME CHEER while participating in Booster Club activities and/or sponsored events.

I acknowledge that my failure to abide by the participation requirements and policies set forth as stated here and in the bylaws shall result in the loss of Active Booster Club Member status and all benefits incurred. I understand the contents of this agreement along with the bylaws and agree to comply with their conditions. I have had the opportunity to ask questions about any and all parts of the agreement and bylaws that I do not understand.
