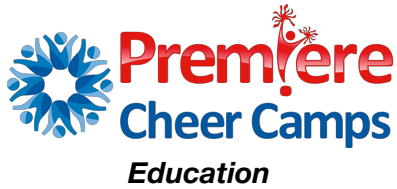

Staff Instructor Candidate Video Tryout Requirements

Cheer

Perform one cheer that highlights basic motion and cheerleading techniques. Candidates may incorporate other skills as well.

Sideline

Perform one sideline that highlights basic motion and cheerleading techniques.

Jumps

A toe touch is required for all female and male candidates. Candidates may also choose to perform other jumps as well that highlight their abilities (herkies, hurdlers, pike, etc.)

Partner Stunts

OPTIONAL — Coed and all-girl stunts are acceptable. The primary purpose for stunting is to demonstrate how well you perform basic cheerleading stunts (double based elevators, toss hands, one leg stunts, etc.)

Dance

MALE CANDIDATES are not required to dance, but may if the candidate would like.
FEMALE CANDIDATES are required to perform a routine of at least 8 eight counts in length. Candidates should NOT perform their school fight song.

Tumbling

A segment highlighting your tumbling strengths. The following is recommended:

- Standing back handspring
- Roundoff back handspring
- Back tuck
- Other standard tumbling skills

While it is not required to have each of the aforementioned skills, any gymnastics you are capable of doing will help us determine your overall abilities. Regardless of your tumbling ability, you must be able to spot a back handspring for instructional purposes. Many of our staff are not advanced tumblers. DO NOT let this portion of the requirements prevent you from applying! Some of our most successful staff members have had little to no tumbling ability!

Additional Notes

Please ensure all requirements are present in the video. Lack of tumbling ability will not be a determining factor.

More than one applicant may be present in the video; however, please include a name list of those trying out in the order in which they appear.
