## What is Non-Tumbling Open 4?

Non-Tumbling is exactly what it says – no tumbling required. Routines are made up of stunts, jumps, pyramids, baskets, dance and choreography – non-tumbling teams have a 2:00 routine instead of a 2:30 routine. Open means there is no upper age limit for this team. And the 4 stands for the level of stunts, pyramids and baskets the team can perform!

## Who can participate?

If you are a male or female born in 2011 or before, you are eligible (you must also be able to pass a background check if 18+). We prefer that our athletes have prior cheerleading or dance experience, but it's not required. This team is perfect for prior all star athletes or high school cheerleaders who have

# Financial Policies

\*All-inclusive fees cover instructional hours, choreography camp, equipment fees, administrative fees, insurance, end-of-season award ceremony, competition fees, coaches competition/travel fees, uniform top and bottom, competition bow, and Season 13 tee shirt. Additional apparel and accessories will be available, but not required. Athletes starting later in the season will have a higher monthly payment, as season fees are the same, but will be divided over fewer months.

\*Payment is due on the 1<sup>st</sup> of each month by automatic withdrawal from a major credit/debit/ATM card unless otherwise arranged on your contract. All payments, charges and fees are handled through the Fusion Parent Portal. Every member MUST have a credit card on file, and by registering,

\*You will have access to the Fusion parent portal, so you have your account at your fingertips. Log on to see account history, update card info, make payments or view your upcoming fees. If you have questions about your account, please let us know before the 1<sup>st</sup> of the month.

\*It is the responsibility of the person signing the contract to meet all financial requirements. Fusion does not coordinate payments between ex-spouses unless they are both present and sign separate contracts. Athletes under 18 must have a parent sign their contract. They are not allowed to sign financial contracts, and cannot be held responsible for fees.

\*If payment has not posted by the 10<sup>th</sup> of the month, a \$25 late fee will be assessed, and the athlete will be removed from practice until payment is made. Accounts that reach 30 days past due will cause us to remove your child from our program, and send your account to an outside collection agency.

\*All fees are non-refundable after the first 2 practices. When you sign up for a team, Fusion commits to pay for travel expenses, uniforms, etc. on your behalf, and when an athlete leaves the program, we are often obligated to pay for these commitments. Therefore, we will be unable to refund any portion of the fees paid if a participant chooses to leave Fusion Elite before the season is over.

\*Fusion Elite requires a 30 day written drop notice. Tuition is due during those 30 days. Oral notices are not acceptable. No drops are allowed between January and April – drops during this time are particularly damaging to the team and routine. Athletes who drop during this time will still be required to pay tuition and all other team expenses until the end of the season.

\*We do our best to give you an accurate estimate of what expenses will be incurred during the season, and every effort is made to reduce costs wherever possible. We will notify you as soon as possible when an actual cost differs from the estimates listed here, and reserve the right to add an additional charge to your account if there is an increase in the anticipated costs.

\*Uniforms are used on a 3-year cycle. This is year 1/3.

\*Parents are responsible for purchasing their own shoes, link will be given once the season starts to order.

\*You give the right to Fusion Kids Center, INC to charge the card on file for all fees incurred throughout the season.

\*Starting August 1st, a \$25 fee will be charged for each missed practice. Athletes are allowed up to 8 missed practices during summer (May-July) without penalty.

\*Any monetary awards earned by teams at competitions and will not be distributed to individual athletes and will be absorbed by the Gym.

# Attendance

Athletes must be at practice. Period. Since routines and stunts absolutely require the presence of each team member, missing practices, being tardy, and/or leaving early from practices, events or competitions is not tolerated. Absences and tardiness will affect the athlete's placement on his/her team and in his/her routine.

\*Under no circumstances may an athlete miss practice the week leading up to a competition.

\*Using practices or competitions as leverage for discipline is not allowed, as this will cause stress on the whole team.

\*Extra practices are sometimes required before events, depending on the needs of the team. We will give as much advance notice as possible.

\*Athletes may be moved in the routine, removed from stunts, pyramids and sections of the routine if an athlete's attendance creates a hardship or safety issue for the rest of the team.

# Classes

\*Tumbling and cheer classes are optional, but a great way to further your skills in cheerleading. Team practices are reserved for routine work, so individual skill development must be done in classes.

\*We offer an unlimited season class pass upon registration, which gives you unlimited classes for your whole season for only \$79/month. This is a 40% discount from our regular fees. Unlimited class pass may only be purchased when registering, and is a contract for the full season (through April.)

\*Those who choose not to purchase the unlimited class pass can still attend classes at the regular rate.
