## Acceptance of Terms & Conditions

Please take a moment and read carefully to ensure that you fully understand the time and financial commitment required for World Class Allstars. You will need to initial each section and sign at the bottom of the page

- My child must attend all practices, showcases, and competitions. It is imperative that the participant arrives at all practices, competitions, or other scheduled events on time. Punctuality is a must!
- I am responsible for the complete season of monthly tuition for the season payable to WCA.
- If I choose to leave this program I am not eligible for any refund of payments or fundraising funds.
- The participant must respect the dress code. Hair must be tied back away from the face, cheer shoes tied, and in practice uniform. No jewelry is allowed at practice or competitions. No nail polish is allowed at competitions.
- Personal belongings should be left at home. WCA is not responsible for lost or stolen property.
- If my child is sick, he/she is still required to attend practice (unless permission is obtained from a coach prior to practice). He/She will not be required to participate but is required to attend.
- I cannot use "grounding from the cheer team" as a form of punishment as this is detrimental to the entire team and not just one team member.
- If there is a question or concern, I will contact the office, head coach, or gym owner without involving other parents/athletes.
- GOSSIP will NOT be tolerated about other teammates, coaches, WCA programs, or other gyms. Drama will not be tolerated at any level.
- There will be NO profanity or abusive language in or around the gym or at competitions.
- All team members, parents, family members, and friends will show good sportsmanship, polite manners, and a kind disposition at the gym and at competitions.
- No one is allowed to post routines on any social media until approval from the gym owner is received. No one is allowed to share team or gym information with other persons involved with competing gyms.
- I am responsible for communicating any injuries that my child has, whether it happened inside or outside of the gym. I will provide a doctor's note when necessary.
- I will need to attend all parent meetings or have someone there to take notes for me in my absence.
- NO parent/athlete/family member or friend is authorized to speak to a competition official ever.
- My child must wear their assigned practice uniform to every practice. I understand that if my child does not have the complete uniform including cheer shoes they will be required to run laps.
- I will be respectful to all WCA coaches, staff, and volunteers.
- Each team and parents/family/friends should watch and support all of our teams at competitions when they are able. Good sportsmanship is a must!
- Practice days and times may change throughout the year to accommodate either coaches' or the gym's schedule. If there is a change the gym will notify thru email and text.
- I will provide an email address that is regularly checked to the gym since that is the most often used form of communication.
- No one is allowed to yell onto the floor or try to make contact thru the glass viewing area during practices or tumbling classes. This is extremely distracting to all involved. If you need to get info to your child please tell the front desk person and they will help you.
- Parents are never allowed to represent WCA under any circumstances concerning accommodations, competitions, or any other situation.
- These policies may be changed by adding or subtracting any rule at any time.
- I understand that a parent's negative actions and attitude can result in their child's dismissal from the program. Remember, there could be someone listening to your conversation no matter where you are. This includes all social media outlets.
