



ICT Cheer Legacy Waiver

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person to person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

ICT Cheer Legacy has put in place preventative measures to reduce the spread of COVID-19; however, ICT Cheer Legacy cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending ICT Cheer Legacy could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19, and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending ICT Cheer Legacy and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at ICT Cheer Legacy may result from the actions, omissions, or negligence of myself and others, including, but not limited to, ICT Cheer Legacy employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including but not limited to injury, illness, permanent disability, and death), damage, loss, claim, liability, or expense of any kind, that I or my child(ren) may experience or incur in connection with my own or my child(ren)'s attendance at ICT Cheer Legacy or participation in ICT Cheer Legacy programming ("claims"). On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless ICT Cheer Legacy, its employees, agents, and representatives of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of ICT Cheer Legacy, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any ICT Cheer Legacy program.

I hereby grant the permission necessary to allow the Minor to participate in ICT Cheer Legacy activities. I acknowledge and agree, in my own behalf and on behalf of the Minor, that such participation subjects Minor to the possibility of physical illness or injury (minimal, serious, catastrophic and/or death) and that I, in my own behalf and on behalf of the Minor, acknowledge that the Minor is assuming the risk of such illness or injury by participating in the event. In the event of such illness or injury, I authorize ICT Cheer Legacy Inc and or the Wichita Sports Forum LLC to obtain necessary medical treatment for the Minor and hereby, in my own behalf and behalf of the Minor, release affiliates (herein collectively "Releasees") in the exercise of the authority. I further acknowledge and understand that I am responsible for any and all medical and related bills that may be incurred on behalf of the Minor for any illness or injury that the Minor may sustain during the event and while traveling to and from the site for the event whether or not the event actually occurs.

I, in my own behalf and on behalf of the Minor, further agree to release and hold harmless from any and all liability for negligence or any other claim, judgment, loss liability, cost and expenses (including, without limitations, attorney's fees and costs) arising out of or connected with the event, including any claim arising out of or connected with any illness or injury that the Minor may incur or sustain during the event, all activities associated with the event and while traveling to and from the site of the event, successors, assignees, executors and administrators against loss from any further claims, demands or actions that may subsequently be brought by Minor and by any person or persons on account of damages of any character loss, damages or costs Releasees may have to pay as a result of any such action, claim or demand.
