



COVID-19 GYM MEMBER WAIVER AND RELEASE

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

STARS VIPERS TRAINING CENTER has partnered with HB Ultimate Training Center and has put in place preventative measures to reduce the spread of COVID-19; however, the gym cannot 100% guarantee your safety from COVID-19 within the gym's premises. As such, the gym will require an undertaking of risk and waiver of liability from all customers before we can allow them on the gym premises.

1. I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by attending the gym and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

2. I understand that the risk of exposure extends to anyone with whom I have regular close physical contact, including members of my household (partners, children, parents and others).

3. I understand that the risk of becoming exposed to or infected by COVID-19 at the gym may result from the actions and omissions of myself and others, including, but not limited to, gym employees, volunteers, and program participants and their families.

4. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my may experience or incur in connection with my attendance at the gym or participation in gym programming.

I, _____, HEREBY WAIVE AND RELEASE indemnify, hold harmless and forever discharge, **STARS VIPERS TRAINING CENTER** and its agents, employees, officers, directors, affiliates, successors and assigns, coaches, teachers and trustees of and from any and all claims, demands, debts, contracts, expenses, cause of action, lawsuits, damages, and liabilities, of every kind of nature, whether known or unknown, in law or equity, that I ever had or may have, arising from or in any way related to my participation in any of the events or activities conducted by, on the premises, of, or for the benefit of, **STARS VIPERS TRAINING CENTER**, provided that this waiver of liability does not apply to any acts of gross negligence, or intentional, willful or wanton misconduct arising out of exposure to COVID-19.

6. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the gym, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any gym activities.
