Parties are for children - Adults are prohibited from using the equipment, such as trampolines, double-mini trampolines, rope, etc. Please respect the rules posted in the gym for the safety of all participants. For example: the rope is a climbing rope, not a swinging rope - do not tie a loop and swing children on the rope, one at a time on the trampolines - see the board posted in the gym for more information. We reserve the right to end the party at any time if safety rules are not being followed or for any other necessary reason.

Participants will specifically assume all risks of injury arising out of his or her presence on or about the premises, or his/her use or intended use of equipment or facilities, or his/her participation in the activities, including attendance of birthday parties, of Studio 50 Gym, Dance & Cheer Center, LLC. I am fully aware that any activity involving motion, height or athletic activity creates the possibility of injury, including but not limited to scrapes, cuts, bruises, sprains, breaks, muscle injuries, concussions or other serious injuries. I fully understand and accept these risks as well as that are unknown to me upon the signing of the Agreement that may result in medical assistance, medical expenses and medical emergencies. I hereby release Studio 50, including, its officers, owners and employees from any liability of any such injury. I further agree to hold harmless, indemnify and defend Studio 50, including it's officers, owners, and employees from any loss, liability, damage or cost incurred by them at any event at Studio 50. This release includes but is not limited to any claims of negligence, dangerous conditions, latent defect, premises liability, code violations, negligent security, failure to warn, vicarious liability, negligent hiring, supervision, maintenance or improper/dangerous equipment; it is intended to be as broad as permissible under Illinois law.
