

### What is All-Star Elite Cheer?

All Star Elite Cheer is a discipline of cheer that involves athletes performing a 2 1/2 minute routine composed of tumbling, stunting, pyramids, dance, and cheer segments. All-Star Elite cheer teams are most often organized and based out of a club and have teams who are open to all area athletes. All-Star Elite teams will practice twice a week with the occasional extra practice as needed. Teams will compete locally and at events within an approximate 3-4 hour travel radius. Additionally, some year-end events do require travel outside of Texas. Out of State competitions will be discussed with individual teams as bids are earned for these large events.

#### What is ALL-STAR PREP?

All-Star Prep is a GREAT way to experience All-Star cheerleading with less financial obligations and less cheer competitions. All-Star Prep teams will practice twice a week with occasional extra practices if needed. Our Prep teams will compete mostly in Houston/Galveston area competitions but do occasionally travel to San Antonio or Dallas for events. Our All-Star Prep teams will be treated no different than our All-Star teams; we expect them to be just as competitive. Additionally, some year-end events do require travel outside of Texas. Out of State competitions will be discussed with individual teams as bids are earned for these large events.

### What is ALL-STAR SHOW/NOVICE?

All-Star Prep is an introductory level to elite cheer, designed for athletes ready for competitive cheer who may be newer to the sport or skills acquire when moving to a higher level team. Many athletes moving from level to level may be placed on a prep team for a season to help them prepare and become consistent with the new level's skill requirements prior to moving into the elite team for that level.

All-Star Show and Novice is a GREAT way for our very young athletes to experience All-Star cheerleading with much less financial obligations and less cheer competitions. Athletes as young as 3 years old can participate in this program. All-Star Show/Novice teams will practice once a week with occasional extra practices if needed. Our Show/Novice teams will compete in Houston/Galveston and surrounding areas area. Our All-Star Show/Novice teams teach athletes the value of team work and hard work while in a fun and age appropriate environment.

#### **COMPETITIONS:**

We will release the 2022-2023 competition schedule mid August to early September for ALL teams. Cheer Factory typically attends 7-9 competitions for All-Star Elite, All-Star Prep typically attends 6-8 competitions and All-Star Show/Novice 5-6 typically competitions. Some National Championship competitions require a 1-2 night hotel stay, which are mandatory by the event producer though some do offer exemptions with approved forms that must be submitted by their deadline. Additional information regarding "stay to play" events will be discussed at the parent meeting. Many competitions last ALL day so keep these days totally free. Staying for awards will be MANDATORY.

#### **HOTELS:**

Once the competition schedule is finalized, the gym will select a host hotel and reserve a "block" of rooms from which you may reserve your personal rooms. Cheer Factory will not require athletes to stay in the same hotel; this "block" is to make reservations easier for families and hopefully provide a cost effective "group" option.



#### **TRYOUTS:**

Tryouts will be held in May with team practices beginning in June. Athletes will go through a relaxed evaluation of tumbling, jumps and flexibility (only flyers). Athletes should wear comfortable athletic tshirt, shorts and shoes. Hair should be pulled back in a ponytail style out of the face. **PARENT MEETINGS WILL VARY BY LOCATION AND WILL BE POSTED WITH RESULTS.** 

#### **TRYOUT RESULTS:**

Team placement results will be posted on our website, Instagram and Facebook page. Practices for the new season will begin in June. In order to allow our athletes to enjoy their summer we will allow practices to be missed, with advance notice and a vacation request submitted. However, CF will have mandatory practice days for choreography and stunt choreography camp, athletes not in attendance will not be included in whatever section the team is working on that day. During June and July, it is possible that athletes may be moved around to other teams at the coach's discretion. Regular MANDATORY practices will begin in August.


### **WORK GROUPS AND TEAM FINALIZATIONS:**

Work groups will begin in June after end of season events for our teams and tryouts are concluded. During this time, we will have normal team scheduled practices. We call these work groups to give our athletes time to continue working on skills they may need to perfect. During this period of time, athletes can be moved around from team to team. We will finalize teams before we begin choreography.

# FINANCIAL OBLIGATIONS

# **Monthly Tuition:**

Our monthly tuition includes your athlete's practices each week, any additional practices scheduled by their coach and tumbling class(es) as outlined in the Financial Breakdown Chart. This year athletes will be required to pick their weekly classes to avoid classes becoming too full. We require that all families put a card on file per our policy and tuition not paid by the 5th of each month will be drafted automatically. ALL athletes are required to attend tumbling at least once per week.

# All-Star Elite/All-Star Prep/All-Star Show and Novice Fees:

All-Star Elite, All-Star Prep and All-Star Show/Novice fees include competition fees, music, choreography camp and coaches' fees. All Star will use the same uniforms as last season, so returning athletes will not need to purchase a new uniform unless they have outgrown theirs or are moving from a Youth/Junior team to a Senior team. All Star Prep will get new uniforms this season, all Prep athletes will be required to purchase a new uniform. All Star Show/Novice also will use the same uniforms as last season, so returning athletes will not need to purchase another uniform unless they have outgrown theirs. Athletes new to the program may be able to purchase a gently used uniform from another family and are welcome to do so in lieu of purchasing a new one for All-Star and Show/Novice teams.

**NOTE:** The total of these expenses can be paid through our Cheer Factory Payment Plan as described below in this packet, in addition to monthly tuition. Any other arrangements must be approved by Cheer Factory. Attendance at practice is an important part of a successful team. In some cases, it is necessary to miss practice due to events that are not in your control. Therefore, a list of excused and unexcused absences will be given out at the first parent meeting. Excessive absences can result in an athlete's removal from the team or a \$25 FINE PER OCCURRENCE billed to your account if NOT EXCUSED IN ADVANCE. Excessive absences due to illness will require a doctor's note. Athletes that are injured are still expected to attend practice to learn changes and upgrades.



# **ALL STAR ELITE PAYMENT PLAN**

Option #1 Pay in Full: This option allows the parent to fulfill the financial obligation in full and receive a \$200 discount. Payment must be received by June 10 <sup>th</sup> to receive discount. This discount does not apply to monthly tuition. Tuition fees will continue to be drafted monthly as outlined above. All Star Uniform and additional spirit gear are not included in this payment plan.
Option #2 50/50 Payments: This option allows the parent to fulfill the financial obligation in full in two equal payments and receive a \$125 discount. With this option the initial 50% payment is due no later than June 10 <sup>th</sup> and the remaining 50% payment due no later than August 10 <sup>th</sup> . This discount does not apply to monthly tuition. Tuition fees will continue to be drafted monthly as outlined above. All Star Uniform and additional spirit gear are not included in this payment plan.
<b>Option #3 4 Payments:</b> This option allows the parent to fulfill the financial obligation in full in four equal payments and receive a <b>\$75 discount</b> . With this option the initial 25% payment is due no later than June 10 <sup>th</sup> , the 2 <sup>nd</sup> payment due by July 10 <sup>th</sup> , the 3 <sup>rd</sup> payment due by August 10 <sup>th</sup> and the remaining 25% payment due no later than September 10 <sup>th</sup> . This discount does not apply to monthly tuition. Tuition fees will continue to be drafted monthly as outlined above. All Star Uniform and additional spirit gear are not included in this payment plan.
Option #4 Monthly Payments: This option is designed for those who desire to make monthly payments, beginning in August 10, 2022 and ending April 10, 2023. With this option an initial deposit payment of \$350.00 is made no later than June 10th, a second deposit payment of \$250.00 is I made no later than July 10 <sup>th</sup> followed by 9 consecutive monthly payments of \$180.00. All monthly payment plans MUST be on auto draft. This payment is in addition to your monthly tuition. Tuition fees will continue to be drafted monthly as outlined above. All Star Uniform and additional spirit gear are not included in this payment plan.

This discount does not apply to monthly tuition. Tuition fees will continue to be drafted monthly as outlined above. All Star Uniform and additional spirit gear are not included in this payment plan.
Option #2 50/50 Payments: This option allows the parent to fulfill the financial obligation in full in two equal payments and receive a \$95 discount. With this option the initial 50% payment is due no later than June 10 <sup>th</sup> and the remaining 50% payment due no later than August 10 <sup>th</sup> . This discount does not apply to monthly tuition. Tuition fees will continue to be drafted monthly as outlined above. All Star Uniform and additional spirit gear are not included in this payment plan.



- Accounts with a balance MUST meet with management before signing up for classes. CURRENT CF MEMBERS WITH DELINQUENT ACCOUNT HISTORY WILL BE REQUIRED TO PAY AN ADDITIONAL DEPOSIT PER ATHLETE UP FRONT TO REGISTER FOR A CLASS.
- Tuition Fees will post to your CF account on the 20th of the month prior to which it's due should be paid by the 25th of that month. A late fee of \$25.00 will be applied if payment is not received by the 1st of each month.
- Competition/Team Fees will post to your account by the 5th of each month and should be paid by the 10th of each month (unless they are paid in full). A late fee of \$25 will be applied if not received by the 15th of each month.
- All unpaid balances will be charged to the card on file on the 5th of each month with late fee for tuition and the 20th of each month for competition/team fees. Declined charges will result in suspension from classes/practices until paid.
- If you prefer NOT to charge the card on file, you must bring in cash or check by the 1st of the month for tuition and the 10th of each month for competition/team fees (or sooner should the gym be closed). Additional grace period will not be given if these dates fall on a weekend.
- All accounts are required to have a valid credit card on file at all times even if paying by cash or check monthly. It is your responsibility to fill out a new CC authorization form for lost/stolen/expired cards, billing address changes, etc. All applicable fees will be charged if the card on file is declined for ANY REASON.
- For check payments, if payment is returned for any reason you will have 24 hours to clear the account or a \$25.00 late fee will be applied. In the event of any returned payment, a \$35 NSF/processing fees will be charged to my account and will be due with payment.
- No account will be allowed to have fees roll over from month to month.
- Athletes with a balance will not be allowed to participate in class until ALL fees are paid in full.
- If my athlete plans to drop from any Cheer Factory class, I must submit the required withdrawal notice to the gym office or email to cfstaff@cheerfactorytx.com by the 1st of the month prior to the last month my athlete will attend.
