



**Powerhouse Tumbling Inc-Policies & Waiver**

**TUITION PAYMENTS**

Tuition is due the first week of each month. If no payment has been received by the 10th of the month, there will be a \$10.00 late fee assessed. You may pay inside the gym with cash or card or pay online directly from the payment link embedded in the invoices sent to the e-mail address on your child's registration form. Every month's tuition rate is the same. No fees, tuition, or payments are refundable. The returned check charge is \$25.00.

**WITHDRAWAL POLICY**

You are registering your child for the time period as of today through the end of the following year. Should you choose to withdraw your child from our program, a 30-day notice is required. There are two acceptable procedures to withdraw from classes. 1) E-mail dalaina@powerhouseok.net that you wish to discontinue classes. A reply will be given upon receipt of your request and final arrangements will be made to close your account and cancel your contract. Please keep a copy of this email for yourself as well. 2) Withdraw from class in person with any Powerhouse coach. An email will then be sent to you regarding the final arrangements needed to close your account and cancel your contract. If you choose to just quit attending classes, your child will be automatically dropped after one full month of no attendance and you will still be responsible for the final payment of that final month's class fees.

**RELEASE OF LIABILITY**

I represent that I am the parent or legal guardian of the child enrolled with Powerhouse Tumbling Inc (hereafter referred to as "my child"). In exchange for Powerhouse Tumbling Inc, allowing my child to attend its classes, and on behalf of myself, my child, my spouse, my family members, heirs, successors, assigns, and anyone acting on my behalf and/or my child's behalf, I hereby release, indemnify and hold harmless, its owners, members, directors, employees, agents, affiliates, subsidiaries, and all other related entities, Powerhouse Tumbling Inc successors and assigns (hereafter cumulatively referred to at times as "Released Persons") from any and all liability, claims, demands, causes of action, lawsuits or any other legal proceeding whatsoever, arising out of or related to any loss, damage, or injury, that may be sustained by my child and/or the undersigned, while in or upon the premises or any premises under the control and supervision of the Released Persons or in route to or from any of said premises or at any events/performances, including all claims that allege negligence or reckless acts and omissions of the Released Persons.

**ASSUMPTION OF RISK**

I fully understand and acknowledge that there are risks and dangers associated with participation in classes at Powerhouse Tumbling Inc, which could result in bodily injury, partial and/or total disability, paralysis and death. I acknowledge that there are known and unknown risks that cannot be reasonably eliminated from the activities that I voluntarily agree for my child to participate in. Some of the risks resulting from my child's voluntary participation include, but are not limited to scrapes, cuts, bruises, serious injury to one's person, sprains, breaks, muscle injuries, acts and omissions of other students. I accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis or death, however caused and whether caused in whole or in part by the negligence or recklessness of the Released Persons.

**MEDICAL EMERGENCY**

The undersigned gives permission to Powerhouse Tumbling Inc, to seek medical treatment for my child in the event a parent or guardian cannot be reached. I hereby declare any physical/mental problems, restrictions, or condition and/or declare the participant to be in good physical and mental health.
