### RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

Gymnastics, dance and cheerleading are vigorous sporting activities involving height and rotation in a unique environment, and as such pose a significant risk of injury. Gymnastics/dance/cheerleading and related activities always involve certain risks, including but not limited to death, serious neck and spinal injuries, and serious injuries to bones, joints and muscles. The risk of such harm may be limited by safety equipment and coaches, but will never be eliminated.

For myself, my spouse, and my child, I knowingly and freely assume all such risks, both known and unknown, and even if arising from negligence of Hot Topic All Stars, Inc., or others, and assume full responsibility for my child's participation.

I willingly agree to comply with Hot Topic All Stars standard and customary terms and conditions for participation in Hot Topic All Star cheer and dance program. If I observe any unusual and significant concern in my child's readiness for participation and/or the Hot Topic All Stars program itself, I will remove my child from participation and bring such issue to the attention of the nearest Hot Topic All Stars personnel immediately.
