

Key Points About Transfer Portal Data


- ▶ The Transfer Portal's entry year spans Aug. 1 - July 31.
- ▶ The year listed when describing trends reflects the latter year of data entry. For example, 2021 data refers to those who were entered into the portal between 8/1/2020 and 7/31/2021.
- ▶ Transfer Portal records are managed by the institution's compliance office.
- ▶ A student-athlete's record will show as active upon entry in the transfer portal and will remain active unless the student-athlete matriculates to another NCAA member institution or the record is withdrawn.

Timing of Division I FBS Football Student-Athletes Entering the Transfer Portal





Percent based on total number of Division I men's sport participants with indoor track removed, N=87,007 in 2020 and 88,003 in 2021 and the number of Division I men's football participants, FBS N=15,737 in 2020 and 16,153 in 2021; FCS N=13,497 in 2020 and 13,307 in 2021 as reported in the [NCAA Sports Sponsorship and Participation Rates Database](#) (Dec. 2021). The Transfer Portal fiscal year is Aug. 1-July 31; the 2021 data spans Aug. 1, 2020 through July 31, 2021. Data updated 1/5/2022.




