

FINAL QUALIFYING MEETS

2021 NCAA Division III Men's and Women's Indoor Track and Field Championships

Division III institutions wanting to host an indoor track and field meet (other than a conference meet) between March 1 and March 6 must petition the NCAA for sanctioning. Marks from non-sanctioned meets during this time period will not be accepted for championships consideration.

Institutions wishing to host a final qualifying meet must understand that they are responsible for the conduct of this meet and must ensure that it is fair for all competitors. This would include ensuring the results are accurate and submitted within the required time schedule.

All materials to host a 2021 final qualifying meet must be submitted to Laura Peterson-Mlynski (email: lpeterson@ncaa.org) by **Dec. 1**. Upon receipt of the form, you will receive an email confirmation from the NCAA stating that they have your form. If you do not receive the receipt, please call or email to ensure your application was received by the deadline. The NCAA Division III Men's and Women's Track and Field and Cross Country Committee will review the application (see second and third pages) and post the approved list online by Jan. 20. Qualifying criteria are located on the NCAA Division III Men's and Women's Indoor Track and Field Landing Page on ncaa.org. Each institution may host only one final qualifying meet prior to the championships. To host a final qualifying meet, institutions must submit the following materials:

- ☐ Final qualifying meet application (second and third pages of this document).
- ☐ Proposed schedule of events and meet information (see attached template).
- ☐ Starting heights and progressions for vertical jumps and advancement procedures for all events (based on anticipated number of entries). (Must be submitted to NCAA by Monday, March 1 or 24 hours prior to meet, whichever is earlier. Must be published to all participants at this time.)
- ☐ Please note that in accordance with the qualifying criteria (4g), if necessary, the Hy-tek results may be required to submit if there are challenges and/or discrepancies.
- ☐ Completed curbing form (fourth page of this document, for submission post-event). Must be submitted within 24 hours after the event.

Additionally, each final qualifying meet shall have live results for the meet. If the above requirements are not met, your institution may lose the opportunity to host a final qualifying meet in the future.
