INFORMATIONAL ITEMS.

1. **NCAA vice president of women's basketball update.** The NCAA Division I Women's Basketball Oversight committee received an update on planning for 2021 NCAA Women's Final Four and efforts to reduce expenses at the NCAA national office.
2. **COVID-19 updates and discussion.** The WBOC received an update on feedback received to date on the September 16, 2020, NCAA Division I Council actions, including the start of season date, reduction in maximum contests and sports sponsorship minimums. There are other regulatory issues that will be addressed at future meetings, including seasons of competition and extension of the temporary dead period. In addition, information will be provided to the membership on playing rules, officiating and gameday operation protocols for the upcoming season.
3. **Update from the Working Group on Transfers.** The WBOC received an update from the chair of the Working Group on Transfers on the uniform proposal to permit student-athletes to transfer and be immediately eligible, if certain criteria are met. The oversight committee noted the difficulty in preventing tampering by third parties that engage in impermissible recruiting activities. There will be an opportunity to provide feedback on the proposal once the proposal introduced into the legislative cycle in October.
