That the Committee adopt the following clarification: annual and monthly thresholds are intended to provide more defined performance standards, accountability, and transparency to achieve the goals and objectives of 4.4.2 Alternative 2 – Universal Sector Exemption for Redfish.

2. Ms. Etrie moved and Mr. Salerno seconded:

That the Committee include in 4.4.2 Alternative 2 – Universal Sector Exemption for Redfish: The purpose is to establish a universal exemption, rather than an annual exemption, to increase stability and certainty for current and potential participants and improve Council control and oversight of the fishery.

The goal of the redfish universal sector exemption is to achieve optimum yield of the redfish resource.

Objectives include:

- 1. Allow use of an efficient mesh size codend to facilitate harvest of redfish.
- 2. Increase the harvest of redfish while reducing to the extent practicable bycatch of other groundfish stocks.
- 3. Restore flexibility lost with 2020 contraction of the redfish exemption area.
- 4. Remove areas from the exemption which provide little opportunity to effectively target redfish, or little ability to achieve exemption performance thresholds.
