**Dr. John Quinn**, Assistant Dean of Public Interest Law and External Relations and Special Assistant to the Chancellor for Government Relations at the University of Massachusetts (UMass) School of Law, began his first term on the New England Council in 2012 as the obligatory member from Massachusetts. He is a former member of the Massachusetts House of Representatives, where he held positions on several important committees during his 18-year tenure and co-sponsored a number of fisheries-related bills. He provided testimony on behalf of the industry in several venues and was a member of the New Bedford Mayor's Task Force on Fisheries. Dr. Quinn also represented various fishing interests when he practiced law at the firm of Harvey B. Mickelson & Associates from 1989-1992, as well as in his own law practice from 1994-2010. He holds a B.A. in economics from UMass Dartmouth, a J.D. from Suffolk University Law School, a M.P.Adm. from the Kennedy School of Government at Harvard University, and a Ph.D. in public policy from the University of Massachusetts, Boston. Dr. Quinn was selected as UMass Dartmouth's 2016 CARE recipient, earning the "Chancellor's Award Recognizing Excellence in Service." On Aug. 1, 2017, he testified before the Senate Subcommittee on Oceans, Atmosphere, Fisheries, and Coast Guard on Magnuson-Stevens Act reauthorization on behalf of the nation's eight Regional Fishery Management Councils. Dr. Quinn was elected in 2013 to serve as Council vice chair, a post he held for three years before being elected chairman. This is his fifth consecutive year serving as the Council's chair.

Sissenwine**, who was appointed to the Council in 2013, is a retired marine scientist with appointments as a Visiting Scholar at the Woods Hole Oceanographic Institution and as an Adjunct Professor at the University of Massachusetts School for Marine Science and Technology. He has been a consultant with numerous projects worldwide. He also served for five years on the NEFMC's Scientific and Statistical Committee before becoming a Council member. He is a U.S. Commissioner to the Northwest Atlantic Fisheries Organization (NAFO) and a member of the Advisory Committee to the U.S. Section of the International Commission for the Conservation of Atlantic Tunas (ICCAT). He was President of the International Council for Exploration of the Sea (ICES) from 2003-2006, followed by additional service as the Chairman of the ICES Advisory Committee for several years. Dr. Sissenwine served as Director of Scientific Programs and Chief Science Advisor for the National Marine Fisheries Service until June 2005. In this capacity, he directed more than 25 laboratories and approximately 1,500 staff. From 1996-2002, Dr. Sissenwine served as Director of the Northeast Fisheries Science Center, an institution comprised of five laboratories and 300 staffers. He has served on numerous regional, national, and international scientific groups advising on fisheries and marine ecosystems. He received a B.S. in mathematics from the University of Massachusetts in Amherst and a Ph.D. in oceanography from the University of Rhode Island.
