Due to the COVID-19 outbreak, Governor Baker issued an executive order prohibiting gatherings of 10 or more people, effective March 24, 2020. Further, Mayor Mitchell closed City Hall to public access, effective March 17, 2020. This effectively means that boards and commissions may not meet in person with the public during the time these state and city orders are in effect. However, pursuant to a March 12, 2020 executive order issued by Governor Baker that relaxed the requirements of the Open Meeting Law, boards and commissions may meet entirely remotely.
