ESCHEWING THE TRADITIONAL STUDIO SYSTEM, THE FRIDA CURATES A RICH AND ECLECTIC VARIETY OF FILM PROGRAMMING WITH A FOCUS ON DOCUMENTARIES WHICH SERVE TO BOTH EDUCATE AND INSPIRE, INTERNATIONAL FILMS WHICH INTRODUCE AUDIENCES TO CULTURES, TRADITIONS, AND HISTORIES FROM AROUND THE WORLD, REVIVAL SCREENINGS OF REVERED CLASSIC FILMS, STUDENT FILMS PRODUCED BY OUR COMMUNITY OF TALENTED AND VISIONARY YOUNG ARTISTS AND NON-CINEMATIC FARE SUCH AS CONCERT EVENTS, ART SHOWS, EDUCATIONAL PANELS, AND OTHER CIVIC AND ARTISTIC ENGAGEMENTS.
