## **DISTINGUISHING CHARACTERISTICS:**

Sheriff's Detentions Deputy Trainee may be appointed for a period not to exceed six months. Upon successful completion of the Standards and Training for Corrections (STC) certified Corrections Officer CORE course, PC 832 training, including firearms and arrest, search and seizure, Force Options for Detentions training, and introduction and indoctrination training, the trainee must qualify for appointment as a probationary Sheriff's Detentions Deputy or be terminated from the trainee position. Incumbents in the trainee classification are temporary employees and time in the classification does not meet the probationary requirements for Sheriff's Detentions Deputy. Promotions to Sheriff's Detentions Deputy are considered on a merit basis subject to recommendation by the Department head and with the approval of the Director of Personnel. Incumbents are peace officers with limited powers under California Penal Code Section 830.1(c).

## **ESSENTIAL FUNCTIONS:**

- Attends the Corrections Officer CORE course, maintaining at least minimum levels of proficiency in all course subjects.
- Completes introduction and indoctrination training which may include assignments as a detention officer in a learning capacity within Sheriff's custodial facilities; learns functions related to the supervision of inmates, including maintaining security and monitoring inmate behavior.
- Fulfills all requirements necessary for appointment to the position of Sheriff's Detentions Deputy.

#### **OTHER FUNCTIONS:**

• Performs other duties of a similar nature or level as required.

**Ability to:** give clear verbal instructions/directions, testify, and other oral communication; understand and follow oral instructions from others; understand facility forms, reports, manuals and laws pertaining to corrections; accurately observe, recall, and report behavior; maintain discipline without causing unnecessary tension; work with others and interact with diverse individuals and groups; have tolerance for the stress of working in a potentially dangerous environment; have tolerance of highly structured, regimented work environment; maintain self-control when confronted with verbal harassment or threats; stay calm and respond with composure in emergencies; work under close supervision; obey authority; perform repetitive tasks effectively or tolerate long periods of inactivity.

#### **SUPPLEMENTAL:**

All Kern County employees are designated "Disaster Service Workers" through state and local laws (CA Government Code Sec.3100-3109 and Ordinance Code Title 2-Administration, Ch. 2.66 Emergency Services). As Disaster Service Workers, all County employees are expected to remain at work, or to report for work as soon as practicable, following a significant emergency or disaster.
