The Peconic Community School Early Childhood program for 3 and 4 year-olds implements a holistic, play-based, arts-integrated educational approach. With an emphasis on imaginative play, meaningful work, and building a strong connection to community, nature and the arts, the PCS Early Childhood Program ensures children a joyful start to their lifelong learning journey.

- 12:05 Stay & Play begins
- 3:05 Full Day pick-up

Stay & Play: 12 – 3pm

In order to respond to busy families who need full-day care, we offer a Stay & Play program for families that are enrolled in the EC program. Families must enroll their child for fixed days in this program if they wish to participate. Space in this program is limited, and is only open to families who are enrolled in the half-day program. The afternoon will consist of lunch from home, rest, recess and free play. We recommend children in this program be at least 4 years old and/or accustomed to full day care.

Tuition is payable on an annual, quarterly or monthly basis.

The Early Childhood programs are not eligible for reduced tuition.

Requirements

- Children must be at least 3 years old by September 1, 2019.
- All children must be potty-trained. **No exceptions will be made.**
- Enrollment contracts are binding for one year. Absences or schedule changes will not change tuition or fees once an enrollment agreement has been signed and a 4-week grace period has expired.
- We highly recommend children enrolling in Stay & Play be 4-years old, and/or accustomed to a full-day program. All children will be considered for stay and play on a case-by-case basis.

Admissions Process

Learn:

Apply:

Applications are accepted on a rolling basis. Once you have decided that you would like to apply, please download or request our application. Once completed, please mail your application to P.O. Box 273, Aquebogue, NY 11931 with a non-refundable check for \$65.

Visit:

As the next step, we invite you and your child to meet more in depth with the facilitators and administrators of the school to determine if our school is the right fit for your family. Once an application has been submitted, you may schedule a visit for your child, where he/she can spend some time in the classroom. The visit offers an opportunity for your family to ask more questions, to get a sense of a day in the life of the school, and for us to learn more about your child.

Enroll:

PCS will consider your application after all materials have been submitted and your child has visited the school. If PCS has the space and resources to accept your child, we will send you an enrollment agreement. Enrollment agreements must be signed and submitted along with a non-refundable 10% deposit to secure a spot for Fall 2019.
