- Parents who make use of **Payment Plan A** (Annual Plan) are reminded that the annual fee is payable in advance and will be due on 31 December 2018. Any parent who does not adhere to this timeline, will be shifted to Payment Plan B.
- Parents who make use of **Payment Plan B** (i.e. 12 monthly instalments) are reminded that monthly fees are payable in advance. All fees are due on **1st of every month**.



Levies

- **IT Levy:** The IT levy covers the leasing costs of Google Chromebooks for your child's learning requirements, as well as internet access throughout the year. The IT levy for 2019 has been set at R198 per month for Primary School students from Grade 1 onwards. The IT levy is payable for 12 months and is due on the 1st of every month.
- **General Levy:** Tuition fees do not include textbooks, stationery (except in Grade 000 to Grade 1) and other sundry items. As such, a general levy, which covers some of these items, will be billed on your statement in January. In 2019, parents also have the option to pay the general levy over a period of three months should they wish.

The breakdown of the General Levy for 2019 is as follows:

<i>Grade</i>	<i>Cost</i>	<i>Items Included</i>
Grade 1	R2 880	Class Stationery, ER 24 subscription, exploration day, sports programme, school outings, robotics and a STEAM (Science, Technology, Engineering and Mathematics) programme development contribution.

- **Stationery:** Stationery is included in the general levy for Grade 1.
- **STEAM programme development contribution:** Nova Pioneer's STEAM (Science, Technology, Engineering, and Mathematics) vision continues to focus on providing innovative spaces where students and teachers can gather to invent, collaborate, and learn - providing hands-on learning experiences and building STEAM-related skills that will empower our students in the future.

- **Aftercare:** Aftercare is an additional cost for Grade 1 which is not included in the total fee. Should parents wish to use the in-house aftercare service, the monthly cost is R880. Grades below Grade 1 for 2019 has aftercare included in their total fee cost. Aftercare is held until 17h15.
