V.New Business

- a. Chuck Walts, Should the funding of the Irish Debates continue?
 - i. Marty mentioned that the NPDA does not pay any money for the event
 - ii. Brent said that the event does not cost funding
 - iii. Chuck said that it does not appear to be geographically fair and balanced
 - 1. States that process does not seem transparent
 - 2. Stated that it seems as if only schools from West Coast

- iv. Tom Schally queried if we should change the process or just remove the event
 - 1. Chuck responded that the event is not worthwhile
 - 2. But, it should be inclusive of all of the schools in the system
 - 3. Could be changed if the selection process were made more transparent
- v. Brent stated that this year there was just a dearth or demand for students to submit or people to be selected
 - 1. Kevin Calderwood was on the selection committee in years past, he is from the MidWest
 - 2. Brent personally emailed people to plea with them to debate
 - 3. Need a bigger pool of applicants
- vi. Chuck has suggested that perhaps it should be up to a community vote and this seems to be slanted toward a geographic area
- vii. Joey Mavity (APU) queried about the selection of the cmte members, could we add Chuck to the cmte
 - 1. Selection of cmte members usually happens after applicants so there is not a conflict of interest
 - 2. Chuck mentioned that his submission of names does not seem to have a process
- viii. Rebecca Seitman (Wheaton College) had a student that she wanted to submit, but it seems as if their location nd tournament schedule seems to exclude them
 - 1. Chuck said process should be open so that people are not excluded because they do not know people on the circuit.
- ix. Dale Hardy-Short (NAU)
 - 1. Had a student who wanted to be selected and submitted and she was.
 - 2. Student was ecstatic, student found funding to attend the tournament, her History department gave her funding. Increased her sense of accomplishment and value.
 - 3. Does not believe that if it were published about the number of participants, that this would diminish the accomplishment.
- x. Brent's concern this year was just getting people to fill the stage
- xi. Gary Rybold thanked Brent for doing the entire program
 - 1. Feels like community college students do not have the skills to combat the Irish or the British
 - 2. Gary is really happy that this year was transfer students from Community College
 - 3. Have a bit more transparency, but let's continue this
- xii. Dena Counts (ACU) says the paperwork is a but onerous and involved.
 - 1. Had a student that did not want to do it because he "was not a cool kid"
 - 2. Maybe decrease requirements
- xiii. Kasey Gardner (LMC) asked if their was a dropoff in hosting the Irish debaters. Brent said it was increasing number of BP schools who were volunteering to host.
 - 1. Brent mentioned he needs to be careful to send people to schools

who know how to host

- 2. *Irish Times* spends a lot of money
- xiv. Brent asked if the community wants it
 - 1. Kasey Gardner asked for a straw poll.
 - 2. Most raised their hand
 - 3. Brent suggested a number of ways for the process to be adapted
 - 4. BP Nationals wants it, but is too late
- xv. Brandan Whearty wants it. It is why Palomar College is here.
 - 1. Says that it is a way for Palomar College to get funding
 - 2. Chuck said that the best of NPDA are not represented on the stage
 - 3. Not an activity that Tyler debaters get access to.
- b. President Birkholt asked for new business again
 - i. Chuck Walts asked to create a committee to review the process of inclusions for the Irish Debate
 - ii. Joe Gantt clarified that Marty could take that as advice to form a committee from interested parties.
