OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

The NRG Newsletter Giveaway (April 2021 – Goal Zero) (the “Sweepstakes”) is open to: (i) residents of the District of Columbia, Delaware, Illinois, Maryland, Massachusetts, New Jersey, New York, Ohio, and Pennsylvania, who are also (ii) at least 18 years of age at the time of entry; (iii) who are also U.S. citizens or lawful permanent U.S. residents; and (iv) who are also customers of Reliant Energy Northeast LLC d/b/a NRG Home as of the Entry Period Start Time specified below. Persons not meeting the criteria above are not eligible to enter. See additional eligibility requirements below in the Section entitled “Eligibility.”

1. THE SWEEPSTAKES:

These official rules (the “Official Rules”) shall govern the Sweepstakes. The Sweepstakes is sponsored by NRG Home (“Sponsor”) which is a trade name of Reliant Energy Northeast LLC. Goal Zero is not responsible for the promotion or fulfillment of this Sweepstakes or any prize. The Sweepstakes will use an entry platform provided by Sponsor. By entering, you understand that you are providing your information to Sponsor.

2. TO ENTER:

By entering the Sweepstakes, the entrant agrees to be bound by the terms of these Official Rules. Sponsor is not responsible for late, incomplete, void, corrupted, misdirected, or otherwise erroneous entries (including reproduced or photocopied entries) or for any problems, malfunctions or technical difficulties that arise in the entry process. Any incomplete or incorrect entries will be void. Proof of submission will not be deemed to be proof of receipt by Sponsor. Once submitted, all entries shall be the property of the Sponsor and will not be acknowledged or returned. All entries submitted in compliance with these Official Rules and not disqualified are considered “eligible entries.”

The Sweepstakes will consist of: (i) an entry period (“Entry Period”) that begins at 8:00 am Eastern Standard Time (“EST”) on April 22, 2021 (“Entry Period Start Time”) and ends on April 30, 2021 at 11:59 pm EST (“Entry Period End Time”) (collectively, the “Sweepstakes Period”); and (ii) a random Drawing conducted on May 3, 2021 (“Drawing Date”) from among all eligible entries received during the Entry Period. There will be a total of one hundred (50) winners (defined below) selected at the conclusion of the Sweepstakes Period.

Only one (1) entry per entry method below is allowed and duplicate entries will be considered void and discarded.

A. Online enrollment

Please use the mail-in entry option if entering online presents an obstacle to your participation.

B. Mail-In Entry

To enter by mail, during the Sweepstakes Period, entrants must print their full name, address (including zip code), daytime phone number (including area code), and e-mail address on a 3x5 card, and mail such card (with proper postage affixed) to NRG Home, Attn: NRG Newsletter Giveaway (April 2021 – Goal Zero), 3711 Market Street, 10th Floor, Philadelphia PA 19104. To be eligible, mail-in entries must be received by 11:59 pm EST, December 1, 2021 to be eligible to win the Drawing. No entries will be deemed eligible if received after the end of the Sweepstakes Period.

Each mail-in entry will be weighted the same as each Online Entry, each receiving one (1) overall entry into the Sweepstakes. Information from all entries will be used at the discretion of Sponsor for business purposes, including, but not limited to, marketing analytics and to refine plans for future promotions, and each entrant consents to such use of all information contained therein by Sponsor for these purposes. Your information will not be sold.

3. DRAWING:

On the Drawing Date, up to fifty (50) prize winners will be selected at random by Sponsor from among all eligible entries received during the Entry Period. If there are not enough entrants, NRG Home will retain the excess prizes. Each winner will be notified via the email address used to submit, or phone number listed on, the winning entry. Each winner will be required to respond (as directed) to this notification message within forty-eight (48) hours of attempted notification. Alternate winners may be randomly selected by Sponsor from among the remaining eligible entries received if the selected winner: (i) fails to respond timely to the notification or cannot be reached; (ii) fails to execute the release required by these Official Rules; (iii) does not comply with any other rule or condition of the Sweepstakes; or (iv) cannot accept or receive the prize for any reason.

The decisions of the Sponsor, including the selection of the winners, are final and binding on all matters relating to this Sweepstakes.

4. PRIZES:

Fifty (50) winners will be randomly selected to receive one Goal Zero Lighthouse Micro Flash USB Rechargeable Lantern (the "Prize"). One Prize has an estimated retail value of \$24.95. The approximate total retail value of all prizes is \$1,247.05.

The Prize may not be substituted or transferred by the winners. Exact prize details will be determined in the sole discretion of the Sponsor. Sponsor reserves the right, at its sole discretion, to substitute a prize of equal or greater value. All additional expenses incurred by the winners in accepting and exercising the Prize (including, without limitation, any special or extraordinary delivery expenses or taxes) will **NOT** be provided by the Sponsor. Prize and value are subject to change and merchandise availability, and may be substituted in the event of unavailability, product discontinuation or other reason in the sole discretion of Sponsor.

Sponsor is not responsible for any printing or typographical errors in these Official Rules or any other materials associated with the Sweepstakes.
