ESTIMATED EXPENSES

Fees (subject to change) for the 2017-2018 academic year at Nashville State Community College are \$8,020.50 per semester with a total of \$16,041 for two semesters. If you attend in the summer semester, there will be additional fees. Each July our governing board increases the fees effective for the next Fall Semester which begins in August. Medical insurance through a policy negotiated by our governing board is required. This insurance cost for one year is currently \$864 per year and will be added to your fees. More information will be given to you when you enroll. Books and supplies are not included in these fees. It is estimated that tuition and living expenses will total \$35,000 per year.

**You must attend school on a full time basis and will not be allowed to work. Nashville State Community College has no financial aid for international students.**
