Direct Deposit of Student Refunds

A refund due to a student as the result of Financial Aid, cancellation of classes, changes in a student's schedule resulting in fewer enrolled credit hours, or other credits due will be processed as a direct deposit to each student's personal checking or savings account.

Direct Deposit Authorization forms can be printed from the website, or found in the Bursar's Office, room S-203.

Direct Deposit forms are due to the Bursar's Office by Aug. 31 to avoid a Fall '18 refund delay.

Enrollment forms will be processed on a first-come, first-served basis.
