Southeast District Report

The Southeast District met Monday March 14 at 6pm in the Education Building at Cape Fear Valley Hospital in Fayetteville, NC. We had 14 attendees. January minutes were reviewed and approved. Guest speaker Respiratory Therapist Steve Pottenger

presented Post Operative Respiratory Management: Ventilator Modalities, Bipap, CPAP and High Flow Nasal Cannula.

Sandra Lindsey presented the Treasury report. We discussed the lowering of the Federal mileage reimbursement rate to \$0.54/mile and decided to use the Federal rate for district mileage reimbursements.

Margy Priddy RN representative from the Cape Fear Valley Training and Development Department was present for a discussion about the Southeast District sponsoring a full day education seminar in March 2017. The members reviewed the requirements required in organizing and sponsoring such an event. The officers discussed the importance of having commitment from members before taking on such a big task.
