Message from the President – Deb Casper

Change is inevitable, but very few can say they "embrace" it. Teaching often makes me reflect on the past and all the changes that have occurred in health care since I started my career. While I never wanted to be one of those "experienced" nurses who live vicariously in the past, I do believe this year's theme of *Guided by Why* can help us understand change and, hopefully, be willing to embrace it. Let's take a moment to walk down memory lane. Some of you may be able to relate to these, while others will be left to wonder how we ever managed to save anyone.

- The paper chart the good ol' thick cart that needed to be thinned in the prolonged hospitalization. And let's not forget the Kardex the playbook for the patient (diet, activity, meds, tests, IVs, etc). When an order was written, the change was noted in pencil on the Kardex and the order was signed off.
- Limited visiting hours 2 visitors at a time and only for 15 minutes every hour
 with the overhead announcement at 7:45 PM: "Attention visiting hours will be
 over at 8 PM" so everyone go home.
- Overhead announcements no "genies", portable phones.
- The "chain" of respect giving up your chair for the physician. Need I say more...
- No 24-hour intensivist or hospitalist nurses even ran to fires with extinguishers in hand ready to fight.

And the list can go on and on. If no one ever challenged these practices or asked *Why* are they in place, we may still be in those "glory" years. We can use this year's theme of *Guided by Why* to help us understand the past, the path to today, and maybe even help us get a glimpse into the future. Let's use the limited visiting hours as an example. In the past, family members and friends were kept at a distance. The focus was on the patient, and to reduce morbidity/mortality. Starting in the 1990's, a paradigm shift was initiated with a focus on patient/family centered care. Visiting hours became more flexible. Families were asked to help care for the patient instead of sitting on the sidelines. Family presence during resuscitation is becoming the standard, and we are even asking patients/families to be part of multidisciplinary rounds. The patient has always been the center of the care, but the model of care looks very different because someone asked *Why*.

Message from the President, continued — Deb Casper

Children, students and new nurses often as *Why*? This small word is their means of gaining knowledge and insight, but it also helps us all push the boundaries to new levels. *Why* do we give Coumadin in the evenings? *Why* isn't that arterial line reading reliable? *Why* is proning back in favor, especially if done early in ARDS?

Guided by Why can be a light in an otherwise overwhelming world. I encourage us all to reflect on the past, look at the present, and be open to the future. Challenge the status quo and continue to ask Why. You might be surprised by the answer.

November's Educational meeting will include a raffle for an essential oil basket to support a scholarship fund for attendance to NTI. The basket will be available to view at the membership table at the meeting.



Member Spotlight- Jean Hogan

1. Tell us a little about yourself professionally (years of being a nurse, experience, certification, current employment and role, etc.).

My name is Jean Hogan. I received my BSN from Alverno College and have employed as a RN with Froedtert and the Medical College- Community Memorial Hospital (CMH) for 34 years. I have spent the last 27 years on the Modified Care Unit (MCU) which is a step down unit. I worked as a bedside nurse, case manager, a dual role of MCU educator and the Stroke Coordinator, and now serve as the MCU educator. I obtained my initial PCCN certification in May of 2010.

2. Please share what you do to maintain a healthy work-life balance.

I have to be honest that I am not the best role model for work-life balance between my career and caring for an elderly parent. When I do have down time I enjoy camping with my family, spending time outdoors just enjoying the natural sounds of nature and spending time with friends I went to high school with. I believe that you need to be "in the moment" when you do anything at work or play and that helps to keep you focused and balanced. That was one of the big "ah ha moments" I had from attending the NTI conference in 2016.

3. This year's national theme is *Guided By Why*. Please share with us *Why* you became a nurse and got your certification? *Why* did you join AACN - GMAC?

When I was growing up I wanted to be either a nurse or a teacher as I enjoyed helping others and becoming a nurse was the best of both worlds. Transitioning into my current role was a huge time commitment. But, I enjoy the patient/staff interaction. I get to see the staff growing in their knowledge and confidence. I decided to pursue my PCCN certification to validate my knowledge, skills and abilities in caring for the patient population I served. I joined AACN - GMAC at the recommendation of my manager at the time, Deb McCann. I enjoy the educational presentations offered by GMAC, the networking, and all the benefits of being an AACN member. We currently have approximately 7 GMAC members from my unit. Being a part of AACN - GMAC helps to keep nurses in the forefront of this changing healthcare we experience, to get ideas on tactics to help manage the challenges we face at the bedside, and to know that we're not alone in those challenges.

4. AACN's mission focuses on driving excellence. In your current position, how do you incorporate this into your role?

As the unit educator I am constantly at the forefront of change management whether it be a new piece of equipment, a policy or procedure incorporating evidence based practice. Patient safety is at the forefront of everything we do. I need to ensure staff have the competency and resources they need to obtain the best outcomes for our patients.





5. What advice would you give to a person looking at a career in nursing?

I would share how rewarding it is as there are so many opportunities to grow in skills, to interact with different patient populations, and to grow academically. We have the opportunity to be a part of all life changing events birth to death. My advice to current nurses- continue to pursue excellence, learn and be a part of a local professional organization. Join committees at work and be involved in making practice changes to benefit the patient and their outcomes.

6. Please share one memorable story during your career and Why this situation impacted you.

My daughter was diagnosed with Type 1 diabetes, the summer prior to her senior year in high school. Everything I thought I knew about diabetes suddenly changed as I was now the mom and not the "nurse". I remember taking classes, learning how to carb count, and do injections with her. Once, she took the syringe and said "Mom, if I'm going to live with this the rest of my life, I need to just do it" and she did. My family went from being able to eat what we wanted to counting carbs, monitoring blood sugars, and figuring out how to treat the highs and lows. I realized that being a Type 1 diabetic is hard. It is like a job but you never get a vacation, holiday or weekend off. It made me realize that when patients come in with DKA, we should not stereotype them as "non-compliant". Maybe they are doing the best they can as they can never take a break from it. My daughter is one of the strongest people I know. She has taken this disease head on and works to control it vs letting it control her.
