

### **AORN SEW Chapter 5001 Point Sheet**

#### **Purpose of Point Sheet:**

- ➤ Encourage AORN membership
- ➤ Encourage attendance at annual AORN conference
- Encourage chapter participation/education
- ➤ Calculate/award monetary stipends to those with greatest participation

#### **Guidelines 2019-2020:**

- > Points are the determining factor for:
  - Offsetting/reducing annual delegate AORN conference attendance cost <u>or</u>
  - Offsetting/reducing annual AORN chapter membership fee.
    - Chapter membership discounts will only be awarded with unused allocated delegate funds.
    - Maximum of ten chapter membership discounts awarded per fiscal year
- > Only those activities which relate to chapter involvement are to be considered.
- ➤ Delegates/awardees must be current AORN members.
- ➤ Upon acceptance of award, delegates will sign and abide by the delegate agreement form, or funding will not be awarded.
- Funds shall be allocated only if not already compensated by another entity. An agreement of no "double-dipping" for funding will be signed. If it is found that the awardee has been compensated by another entity, the funds shall be forfeited.
- ➤ Points are allocated retrospectively, meaning that submission of a point sheet is reflective of the previous year's participation.

  - Submission of voting receipt will be required to receive stipend
- Submit ORIGINAL receipts to obtain reimbursement to Chapter Treasurer
