3. Government Affairs: NCNA Nurses night is June 2<sup>nd</sup>, 2020. We will sponsor 2 free tickets and 25-30 discounted tickets. Day on the Hill in May, the official date is not published.
4. Certification: CEN Review a success with a profit of approximately \$1500.
5. Student Nurse Liaison: Wake Tech has reached out for a meeting on Sept 9, forwarded to Cardinal chapter.
