Due to the COVID-19 pandemic, NBCSN is working with Prometric to offer remote testing for the summer exam administration window. In order to offer this to candidates, NBCSN must first receive approval from ABSNC. We hope to have more information by next week.

The summer exam application window is currently open. The application submission deadline is 4:00 PM ET on June 9, 2020.

## **Recertification Update**

Due to the COVID-19 pandemic, the NBCSN has approved granting a 6-month extension on recertification applications due between March 15, 2020 through October 31, 2020.

NBCSN would like to stress that it is preferred for NCSNs to try to recertify within their regular window. However, NBCSN understands that some NCSNs may be experiencing economic hardship and may have difficulty in obtain their 75 CE. The extension allows NCSNs more time to earn their CE and submit their application. Late fees will NOT apply. NCSNs will be able to keep their current certification window.
