





As critical care nurses we are trained to acknowledge all alarms, however at times we can become desensitized or oblivious to them due to alarm fatigue. This month's article in the American Journal of Critical Care titled, "Skin Preparation and Electrode Replacement to Reduce Alarm Fatigue in a Community Hospital" discusses ways to decrease unnecessary alarms. Alarm fatigue has led to sentinel events and it is our responsibility to ensure this does not become a part of our daily practice.

MAP 40 mm Hg
PAOP 25 mm Hg
Cl 1.4 L/min/m²

- B. obtaining an echocardiogram and administering furosemide (Lasix)
- infusing dobutamine (Dobutrex) and obtaining a 12-lead ECG
