

# **AAP Epilepsy Management ECHO**

The American Academy of Pediatrics is recruiting 20 practices to join a 10-month QI collaborative to improve access to quality healthcare for Children and Youth with Epilepsy (CYE). Practices will engage in the ECHO (Extension for Community Healthcare Outcomes) model ™, a telementoring platform that leverages video conference technology to connect experts with primary care teams in local communities, fostering an "all teach, all learn" approach. Participating practice teams will test, implement and disseminate strategies that lead to improved epilepsy management. Pediatric practices interested in developing sustainable approaches to epilepsy management are encouraged to apply.

## Who should apply:

Practices providing primary care who:

- ✓ Want to improve the quality of care for their patients with epilepsy
- ✓ Can assemble a team of at least 3 members:
  - o A primary care physician
  - o A nurse
  - An additional team member such as front office person, practice manager, or care coordinator
- ✓ Conduct at least ten visits per month with CYE

Preference will be given to practices that serve diverse and/or underserved populations.

- Attend monthly clinic sessions
- Conduct monthly deidentified chart review and input data into QIDA
- Conduct monthly PDSA cycles and submit form

- Complete post-program retrospective survey
- Participate in focus group
- Share lessons learned
