Forensic Nurse Examiner Training Includes:

- 46 nursing contact hours
- Six days of live online training with statewide and national speakers, including virtual courtroom training.
- RNs learn how to provide comprehensive medical forensic care for sexual assault patients.
- RNs will have a certificate of completion for the course. This course is based on current educational guidelines from the International Association of Forensic Nurses. The certificate of completion is a prerequisite to sit for the national certification exam for the Adolescent/Adult Sexual Assault Nurse Examiner.

Outcomes: Learner will have improved knowledge of:

- Working with the sexual assault response team.
- Obtaining a history from the sexual assault patient.
- Completing a sexual assault medical forensic examination.
- Caring for patients from a variety of cultural and social orientations.
- Working with patients that have experienced traumatic events.
- The medical forensic care for patients with disabilities.
- The legal process and court testimony.

Criteria for awarding nursing credit hours:

- Commensurate with participation.
- Completion of evaluation each day
- RNs will need access to a webcam to verify participation.
