

NAPAN 38th Annual State Conference Business Meeting Minutes

October 23rd, 2021

Meeting attendees: Gayle Kiviniemi, Cindy Stehno, Judy Mink, Louise Bergeron and Kristy
Iwansky

- 1. Call to order by President Kristy Iwansky: meeting called to order at 1035am.
- 2. Approval of 2020 Annual Business Meeting Minutes: minutes were approved as written
- 3. Introduction of Board Members & Committee Chairs: no introductions needed
- 4. Review of NAPAN Committee reports; questions: Committee Reports approved as written
- 5. **Treasurer's Report**: Judy Mink: *Report approved as submitted with meeting agenda.*
- 6. Nominating Committee Report/Open Positions, Nominations & Voting: Cindy Stehno: Cindy reported the open board/committee positions as follows: V.P./President Elect; Secretary; and MAL-Membership. Judy agreed to continue as Treasurer, Gayle agreed to continue as Gov't Affairs Chair & Policy/Procedure Chair; Louise agreed to continue as MAL-Finance. Members present nominated Kim Kumwenda to serve as V.P./President Elect, Jill Morris and Kayla Gehring for Secretary, and Cindy suggested combining MAL-Membership committee chair with Past President position would be a nice and practical merger. Gayle made motion to approve this suggestion and Judy seconded, all approved. Gayle will adjust P&P to accommodate this new combined position.

 At this time, Gayle reminded members of opportunity to serve on National Committees and SWAT with WTS forms needing to be submitted to ASPAN by November 21, 2021.
- 7. **Old Business**: Kristy Iwansky
 - a. **President's Report**: Kristy reported she attended virtual meetings with other component and national leaders four times throughout the past year. Topics discussed included: Maintaining and Increasing national & component membership, increasing # of CPAN/CAPA certified members, activities to enhance staying in touch with members & member participation in the midst of the Covid-19 pandemic, and importance of community services/donations. Kristy also presented benefits of ASPAN/NAPAN membership to nursing orientees including distribution of membership apps and WTS forms. Kristy conducted random drawing of names from membership list throughout NE/IA to receive delivery of PANAW gifts; she emailed members and conducted Board/Committee meetings on a quarterly basis using combination of live and virtual opportunities; and s Kristy concluded her report with giving a "huge thank-you" to each of the members present and to each of the past and current board members serving throughout the 2020-2021 year.
 - b. **Progress on 2020-2021 Strategic Goals**: see attached updated Strategic Goals.
 - c. **2021 ASPAN National Conference**: Kristy and several other members represented NAPAN at the 2021 ASPAN National Conference virtually. Research committee members prepared and

- proudly presented their Research Poster (use of a SIM Lab to increase awareness of Perianesthesia nursing to nursing students) during the conference.
- d. Fundraisers and Community Participation: Members reviewed the allotted \$550 donated to Community services. Kristy noted and thanked members who were able to participate "live" in the food drive held at the All-Saints Episcopalian Church on 9/25/2021.

8. **New Business**: Kristy Iwansky

- a. Announcement of Voting Results & Congratulations: No voting took place at this time as members nominated Kim (Kumwenda) Ruhl to serve as V.P./President Elect and Jill Morris & Kayla Gehring to serve as Secretary. Kristy agreed to contact each of these individuals to inform them of nomination and ask for their agreement to serve.
- b. **Strategic Goals for 2021-2022**: Kristy agreed to update the progress toward meeting the current Strategic Goals, present to Board members for approval and then distribute to membership.
- c. Education Programs & State Conference for 2022: Kristy reported a 3-hour Saturday morning program will be presented via ZOOM on January 15th by Dr. Mark Reisbig MD. Program title: "Integrated Care Protocols for Surgical Patients; What we can do together to improve outcomes for our patients". In addition, Rhonda Dennis, APRN has agreed to present a 3-hour program on February 19th on Aortic Aneurysms & Pulmonary Emboli in the surgical patient. On March 19th, Dr. Raynor MDA will present on a potpourri of anesthesia topics (details to be announced). Please save these dates and plan to participate either live or virtually as advertised! Members expressed hope that the February program could be held in-person with a "gift basket" fund raiser and door prizes. No date was chosen for the 2022 NAPAN State Conference at this time.
- d. Community Participation: They also requested donations of personal hygiene products to be donated at the February meeting.

9. Presentation of Awards

Each year NAPAN strives to give back to the community. This year we have done the following projects.


- 1. Food Bank program at All Saint's Episcopalian Church- NAPAN members served meals and helped stock the pantry in September and again in December 2021.

CORONA VIRUS MUTATING AND THE GLOBAL IMPACT A PERSONAL PERSPECTIVE

Corona Virus Mutating and the Global Impact – A Personal Perspective

As Healthcare Providers, we are coming to terms with the fact that Covid 19 is a pandemic that is fully on our radar screens and is likely to be for who knows how long. There has been much written about the clinical effects of this unanticipated pandemic. I would like to offer a first-hand perspective of what this pandemic looks like outside of the United States. During 2021 I travelled twice to Europe, for 6-8 weeks periods, not for personal enjoyment, but out of necessity. The Covid 19 pandemic has been devastational to the world's population in so many ways, but for those divided from each other by oceans it adds an additional layer of anguish.

In late Summer of 2021, travel was lifted to a degree that allowed citizens of foreign countries to travel and reconnect. This may sound like a simple, and welcome opportunity; welcome it most certainly was, simple it most certainly was not. Flying to the United Kingdom in May 2021 required destination citizenship, entailed flying through mainland Europe, a significant amount of preapproved paperwork and was costly indeed. Only vaccinated persons were granted entry that included a PCR test 72 hours prior to flight, a seven-page passenger locator application from Immigration, direct transportation to a "bubble" (a group of no more than 5 individuals who had minimal contact outside their group), PCR testing on arrival and day 2, 5 and 8 and 10 days of strict quarantine. During the quarantine three calls a day, at random times, were received from the British Government, and tracking occurred through cell phone towers and random visits to the quarantine sites. Infraction of the quarantine requirement could result in seriously expensive fines and/or jail time. On day 10 of quarantine, after all testing was reported as negative, there was freedom to restricted movement- all in a mask of course!

Visits to a National Health Care facility required a negative covid daily rapid test and track and trace via a mobile phone. Testing was uploaded into a national data base site which had the ability to inform individuals if they had been exposed at any point. The National Health Service was, and remains, strained to a breaking point, much like the Healthcare Systems here in the United States.

Over the Fall months of this year and as vaccination reached 80% of the population, restrictions eased for England and like other European countries, governments struggled to readjust to a new normal. Now we are on the brink of what is being termed a fourth wave, as Covid 19 mutates yet again (no surprise as this is the nature of a virus) and again England, Europe, and The World is reverting to restrictive global travel, departure/arrival PCR testing and enforced quarantine. This pandemic is tough for all people and all nationalities. This pandemic truly is a global problem that continues to keep national and international people apart.
