ABSTRACT GUIDELINES

Criteria

- Submissions from occupational health nurses, physician assistants, physicians, fellows, including those in residency training, medical school or nursing school, industrial hygienists, students of related disciplines and other OEM related professionals are welcome.

- Posters may focus on research results, case reports, educational projects or professional development. Posters may address any topic relevant to Occupational and Environmental Medicine. Submissions should ideally represent recent work.
- Author(s) may submit more than one abstract for review.
- If accepted, the author(s) or designate must register for at least one conference day and be present for the poster session on Thursday, December 2nd from 4:15 to 6:00 pm.
- Posters must be free of any commercial interest. The ACCME defines a “commercial interest” as any proprietary entity producing health care goods or services, with the exemption of non-profit or government organizations and non-health care related companies.

Format

- Posters should fit an area that is no more than 4 feet high by 8 feet wide. Posters can be hung in the downstairs ballroom any time after noon on Thursday in preparation for the President’s Reception which will be held in the same space. Posters should be taken down immediately after the reception. The Marriott Hotel staff will assist with hanging posters.
- Highly recommended: NECOEM has received a generous donation to cover the cost of up to 10 electronic posters. **The first 10 posters registered will be offered an eposter!** Eposters are easy to install and simply require you to bring your poster slides on a USB. Specs will be sent early in the Fall. - Clarity and quality of the presentation
- Quality of the research methods used
- Absence of commercial interest
