## Keynote Speaker

## Kate King, DNP, M.S., RN, LSN President-Elect, NASN

Kate King has practiced School Nursing for 21 years. She received a Doctor of Nursing Practice from Otterbein University in 2019 and is currently working as a school nurse at World Language Middle School for Columbus City Schools. Dr. King is a strong advocate for supporting School Health Services through practice and legislation, creating Voice in School Nurses, and promoting and providing healthcare to children. Dr. King has clinical experience in Adolescent and Community Mental Health. Her professional interests focus on increasing self-efficacy in School Nurses and Mental Health for school- aged children. She currently serves as the President elect of the National Association of School Nurses, is the immediate Past President of the Ohio School Health Services Association, a founder of the Big 8+ Health and Safety Coalition and is a past Director for NASN and OASN.

## Professor, Penn State College of Medicine

Dr. Robert Olympia M.D. is a pediatric emergency medicine physician with over 20 years of experience, currently working in an emergency department in the Sweetest Place on Earth (Hershey, PA). # Manager, Tick Surveillance and Testing Program Pennsylvania Department of Environmental Protection

Christian Boyer is the manager for the Tick Surveillance and Testing Program within the Pennsylvania Department of Environmental Protection. He develops statewide tick surveillance strategies and guidance to be conducted by PADEP and by county vector control staffs across the state. Previously, he worked in mosquito surveillance and control for 13 years for PA DEP and for another four years at a county level mosquito control program.

#### Brian Parker

## Director of Education, Taylor Hooten Foundation

Brian Parker is a member of the most sought-after Foundation in North America on the subject of Appearance and Performance Enhancing Substances, the Taylor Hooton Foundation. Brian serves as the Director of Education for the Foundation which was founded in 2004, the year following the loss of the Hooton Family's youngest son Taylor. After studying at Elon University and working in baseball, Brian has spent the past 11 years with the organization speaking directly to thousands of people raising awareness about the widespread use of these substances. This program provides a pragmatic view of these substances – What are they? Who is using? Where are they coming from? What are the social issues and pressures driving their usage? How do we navigate dietary supplements? What are the dangers? The program will provide factual information about the world of Appearance and Performance Enhancing Substances so that together we can provide a crucial conversation to our students about properly achieving their goals while living and competing the right way.



### Richard A. Goldberg DO, FAOCRM-D, FAAPMR

## Physical Medicine and Rehabilitation Shriners Children's Hospital Philedelphia

Richard Goldberg, D.O., is a doctor of physical medicine and rehabilitation (PM&R) at Shriners Children's Philadelphia and New England in Springfield, Massachusetts. He has more than 30 years of experience caring for patients with many conditions. He attended medical school at the Philadelphia College of Osteopathic Medicine and held his residency at the Robert Wood Johnson Rehabilitation Institute in Edison, New Jersey. He has served in a few different leadership roles with the American Osteopathic College of Physical Medicine and Rehabilitation, most notably being past president after serving two times.

Since he was young, Dr. Goldberg wanted to go into rehabilitation medicine because of gripping experiences in childhood. When he was 14, his brother passed away from osteogenic sarcoma, a pediatric bone cancer that used to have a very high fatality rate. During this time, Goldberg was introduced to many aspects of pediatric care that he now provides today. From seeing the rehabilitation his brother had, to the care his brother received for a prosthetic limb, Dr. Goldberg started on his path to loving pediatric orthopedic care.

During medical school as he completed his degrees, he needed to find which aspect of care he'd focus on, especially considering Goldberg's hand condition. According to Dr. Goldberg's anecdotal observations, most physiatrists have some rehabilitation-related condition themselves, which influences them to go into rehabilitation. For Goldberg, it's a nerve palsy in his right hand, which makes it difficult to manipulate surgical instruments well, making his choice of rehabilitation medicine even easier.

"This is always where I wanted to end up – devoting my time to children," said Goldberg, speaking about his career in orthopedics and why he joined the team at Shriners Children's. "The mission statement is outstanding, and everyone knows that I agree with it."

His other career highlights include working as the sports physician for Hatboro-Horsham High School, Upper Moreland High School, and Wissahickon High School for approximately 30 years, all of which are in the suburbs of Philadelphia, in southeastern Pennsylvania. As part of the position, he would attend the school sporting events with his family on the weekends, roaming the sidelines and making sure the players stayed safe.

He also ran the infirmary at Camp Nock-A-Mixon in Bucks County, Pennsylvania, for around eight years. He provided orthopedic care to the campers throughout that time, but he noted that there was always something else going on, too. One year there was a swine flu outbreak, and then another, there was a lice infestation. "There was always something going on, so it stayed interesting," said Goldberg.

Morgan Plant has been a registered lobbyist in the Commonwealth of Pennsylvania since 1981. Prior to that time she worked in Washington D.C. in a variety of positions that afforded her the opportunity to become familiar with the workings of the Federal government and the U.S. Congress. ## Colleen Schultz, M.Ed, RN, BSN

## Director, Division of School Health Pennsylvania Department of Health

. Colleen Schultz, M.Ed., RN CSN is the Director of the Division of School Health for the Pennsylvania Department of Health with a decade of experience in school nursing focusing on the K-5 population. Colleen is a Certified School Nurse and has a Masters in Health Education from Penn State. As Director, she plans, directs, and implements statewide consultation and reimbursement programs for health services performed in schools. Colleen develops program policy and goals, serves as a liaison with school districts, private organizations and external stakeholder groups. She collaborates with the Department of Education regarding standards for school personnel and recommends student health assessment policies to the Advisory Health Board. Within her first months of the position, Colleen was forced to confront a worldwide pandemic and the impact on schools and school nurses. Over the past year, Colleen has been an advocate at the state level for the school nurse role in health and safety planning in school reopening and mitigation efforts. She has presented to both small and large groups on a variety of heath topics including hand washing/infection control, nutrition, and dental hygiene.
