Proposed By-laws Change

The Board of Directors proposes to the Membership a change to the Bylaws **Article II, Section 1**. The proposed additional new language is drafted in **Red**. The proposed change will be brought to a membership vote on June 1, 2023, at the Annual Awards and Scholarships membership dinner meeting.

Article II-Membership and Dues

Section 1- Qualifications

A member is one:

~~A student member may participate on committees, and may be appointed to the Board of Directors, but may not serve on the Executive Committee.~~

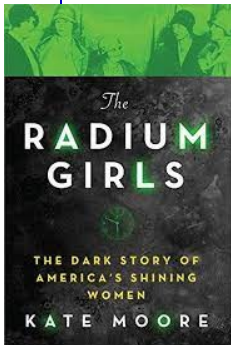

What are YOU reading? Some suggestions, if you please

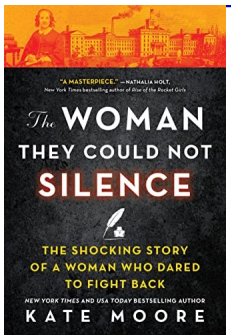

March is **Women's History Month**. It is cold and there is snow on the ground. While I don't know about you, for me, winter provides many great opportunities to snuggle under an afghan, have a cup of hot chocolate, or a nice glass of wine, and read some good books. Four books are ones recently read and one is currently providing nightly reading. All five are non-fiction centered around many *different women* of strength and leadership who persevered, despite overwhelming odds, to make the world a better, safer place.

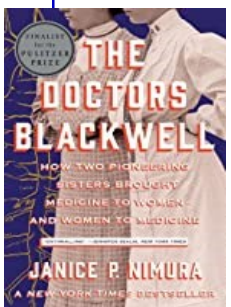


British author Kate Moore recently presented a virtual discussion of two of her works: *Radium Girls* (2018) and *The Woman They Could Not Silence* (2022). Both volumes are very well researched and both are issues that occurred in the United States. One is grounded in the 20th century and the other occurred during the 19th century. Despite that, the issues she writes about are ones we are still dealing with today: environmental poisons, intrigue, coverups, and mental health housing and treatment.

Did any of you have “glow in the dark” watches when you were a kid or did your parents or grandparents talk about wearing one? It turns out that these devices were popularized in World Wars I & II as radium glowed green and could be seen on watch dials, clock dials and cockpit instrumentation. Did you ever think about **how** they were built or **who** painted the dials? Young women fresh out of high school or in their early 20s hired on at the factories because the pay was good and they were contributing to the war efforts. Many of these girls gave only months or weeks to this employment while many others gave years and years of “faithful” employment; but they all paid a terrible price. You need to read this book to find out exactly what happened.



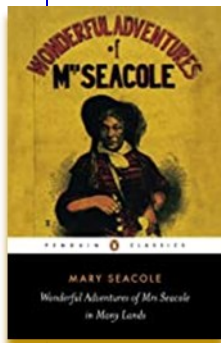
It may be difficult for many women today to understand how a women's identity “disappears” after marriage, but in the 19th century that is exactly what happened. It happened in society before that century, but Moore text starts in 1860. Once married under “femme couverte,” women had no independent rights. They became their husband's chattel. He could do with them whatever he wanted. Such was the case of Elizabeth Packard – a sane woman – who was committed by her husband Rev. Theophilus Packard. Her story is a compelling one which lurked in the shadows of history until uncovered by Kate Moore. As you read these pages, you will come to understand her tenacity, wit, sanity, her passion to become an advocate for both the sane and the mentally ill. You will witness the formation of a mental health advocate who changed the face of mental health treatment in Illinois by 1869. Those changes and her voice are still advocating today. Take the journey – Elizabeth Packard's journey. You will be (hopefully) forever



Now let's spend a little time in Upstate New York to visit with the Blackwell family. Janice P. Nimura introduces the reader to: *The Doctors Blackwell: How Two Pioneering Sisters Brought Medicine to Women—and Women to Medicine* (2021). A strong family, an educated family, saw one daughter break the glass ceiling by advocating for women in medicine, fighting for and gaining admission to and graduation from Geneva (NY) Medical College. Elizabeth started mentoring her sister Emily to follow in her footsteps so Elizabeth's dream of these two siblings practicing women's medicine could be achieved. While their careers diverged, this book is an interesting work about family dynamics, societal “norms,” issues of access for poor women of all ethnicities to health care and issues about education for those women who wanted to pursue a medical career.

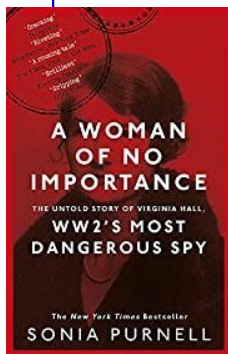
What are YOU reading? Some suggestions, if you please (continued)

The last 2 volumes deal with international nursing in the 19th century, and a woman proving her harshest critics wrong by doing one of the toughest jobs in France during World War II in spite of her mobility issues.

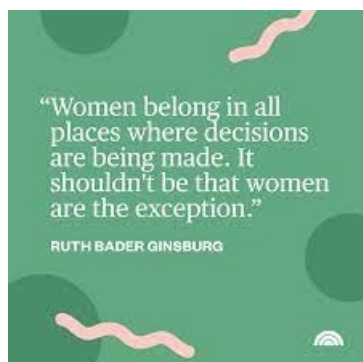


Mrs. Mary Seacole, a nurse, a doctress, an apothecary using herbs, an entrepreneur, and a woman of color was born in Jamaica and grew up there under British colonialism. She learned the healing arts from her mother, a well-respected doctress in Jamaica. She traveled to Panama, opened up a hotel, cared for ill and infirmed and when the Crimean War broke out in 1854, made her way to England to volunteer as a nurse on the battlefield. She was self-assured and creative. Despite denial from “the powers that be,” she made her way to Crimea and made a name for herself there as a nurse, healer, and entrepreneur. You might be able to imagine her first impressions of Florence Nightingale, but she would not be deterred. This book, *The Wonderful Adventures of M^{rs}. Seacole* (1857) tells her lived experiences throughout her life on and off the battlefield. This is a great read. It is wonderful to know that in the last decade, Mrs. Seacole is getting the recognition from Britain that she so rightly deserves.

Last, but not least, is *A Woman of No Importance: The Untold Story of Virginia Hall, WW2's Most Dangerous Spy* (2020) researched and authored by Sonia Purnell. Miss Hall, an American citizen, spent much of her life working for the British as a spy in Vichy France during WWII. While she was not a nurse, she was a person motivated to help those in need and showed her immense skills at leadership and network formation. She was underestimated by many of her family, friends, and colleagues for 3 reasons: she was a woman, an unmarried woman, and she wore a prosthetic leg. What caused this end result you will have to discover for yourself. Suffice it to say that she becomes a mountain climber out of necessity to cross the Pyrenees mountains. She lives an isolated, clandestine life, yet has many protectors. I'm halfway through this book at this writing and can't wait to see how it all turns out.
