ASNC HOSTS 2023 NEW ENGLAND SCHOOL NURSE CONFERENCE

This year the NESNC was held at the Mystic Hilton in picturesque Mystic CT, a charming waterfront community. It began on Friday evening, May 5, with a lively "meet and greet" in the Hospitality Suite with plenty of refreshments and beverages, mostly provided by School Health, which were enjoyed by many. The keynote speakers and breakout sessions were presented on May 6 & 7 with breakfast and/or lunch provided. The planning for this event had begun at least 18 months in advance, which was a bit of a challenge during an ongoing pandemic. There were several unknown factors such as whether nurses would be comfortable traveling to CT, and if sponsors and speakers would be able to make a commitment to us. In the end, it was very well attended with about 188 nurses traveling from all 6 New England states, and a couple from New York too! Official Statement

WHEREAS, students are the future leaders of our state – parents or guardians deserve to feel confident that their children will be cared for at school, and all students have a right to have their physical and mental health needs met while at school; and

WHEREAS, school nurses have played a critical role in improving public health and ensuring student success for over 100 years, and are aware of the home and community factors that impact students' health; and

WHEREAS, school nurses act as a bridge between the school, families, and health care providers on behalf of children's health by promoting wellness and improving health outcomes; and

WHEREAS, school nurses support the health and educational success of children by providing accessible care when children's cognitive development is at its peak; and

WHEREAS, school nurses are members of the school health teams – which include school health services, MTSS/504/IEP plans, mental health support services, and disaster or emergency planning – to address the school population; and

WHEREAS, school nurses understand the link between health and learning, making a positive difference for children everyday; and

WHEREAS, by recognizing school nurses and their importance contributions to our school communities, there is greater hope that more people consider a career in school nursing to help address the shortage of these caring and compassionate individuals working in Connecticut schools; and

WHEREAS, on this day we recognize school nurses across Connecticut and their efforts to meet the needs of today's students by improving the delivery of healthcare in our schools, contributing to communities by helping students stay healthy, and ensuring parents and guardians can know their children are safe and cared for; now

THEREFORE, I, Ned Lamont, Governor of the State of Connecticut – in honor of the many outstanding contributions made by school nurses to our shared community – do hereby officially proclaim the day of Wednesday, May 10, 2023, to be

ASNC's very own Paula Feyerharm MA. RN. who is our President- Elect, was interviewed by Eric Parker from WFSB during Nurses Appreciation Week last month. Paula is the School Nurse Coordinator for Tolland Public Schools, and is also the School Nurse at Tolland Middle School. The interview began with Paula discussing the myriad responsibilities that school nurses have, and outlined the acuity level of skilled nursing care required to enable some students with medical needs to attend public school. For example, they manage students with Diabetes, Epilepsy, G-Tube feedings, catheterization needs, Asthma, fractures, other injuries, concussions, significant mental and emotional health needs, and even ventilator care in a typical school day, to name a few. Although using bandaids, ice packs and a whole lot of TLC are still one of the many tools a school nurse uses, there is so much more to the job!

When asked what she enjoys most about being a school nurse, Paula replied, without hesitation, that she truly enjoys her daily interactions with the students, their families, and the staff. Nurses need to be knowledgeable about so many different aspects of school health, and attend continuing education offerings to keep up with current trends and practices. It should be noted that school nurses interact with every student in the building at one time or another, whether it be by chart review,

immunization requirements, mandated screenings, clinic visits, medication administration, or necessary treatments. She emphasized that nurses always work in partnership with parents and guardians, and encouraged families to reach out to her to keep the lines of communication open.

One of the largest concerns in this post-Covid era is the management and treatment of students' mental and emotional health. One strategy that she often uses is to talk to her students about the positive aspects of where we, as a school community, are now. It's time to look ahead and move forward and learn from past experiences. School nurses also work closely with the other members of the Student Support Team, such as the administrators, counselors, therapists, social workers and psychologists. As you can see, school nursing has evolved into a subspecialty requiring professional skills, compassion, a genuine concern for our children, and a willingness to be a team player. We are all very appreciative of Paula's efforts to promote what we do on an everyday basis.


